Safety will be monitored in regards to design and pressure according to KRS 278.485.

Jakes Branch Gas currently operates under an agreement with Clean Gas, Inc., a management company. Clean Gas personnel handle all well and line maintenance and all other field work. All customer complaints and questions, billing and collections, meter and line maintenance records and all other records required by the PSC will be handled by Clean Gas, Inc.

Jakes Branch Gas will operate according to the same rules applicable to all Kentucky farm tap systems.
