RULES AND REGULATIONS

1. Bills for service will be rendered monthly, the term "month" shall mean the period between consecutive meter readings which shall be taken, as nearly as possible, every thirty (30) days.
2. Bills are rendered on or about the 10th day following the billing period for service furnished during the previous month, and are due within thirty (30) days of the date of the invoice.
3. Service shall be provided to persons who qualify pursuant to KRS 278.485 upon receipt of an agreement, and receipt of any applicable fees and compliance with the applicable statutes and regulations.
4. A reconnection charge of \$25.00 shall be paid before service is restored following disconnection of service for non-payment of bills.
5. For matters not addressed herein, the applicable rules of the Kentucky Public Service Commission shall apply.
