Rules and Regulations

1. Bills for service will be rendered monthly, the term monthly shall mean the period between consecutive meter reading which shall be taken as nearly as possible every thirty days
2. Bills are rendered on the 5th day of the month for service furnished during the previous Month and are due on that date. Bills not paid by the 20th of the month are subject to a 10% penalty. A penalty will not be charged on a penalty.
3. A charge of \$150.00 shall be charged for each new service tap including saddle and First shutoff valve that the Gas Group provides.
4. A reconnection charge of \$25.00 shall be paid before service is restored following Disconnection of service for non payment.
5. A deposit of 2/12 of yearly use will be required for each new account. The refundable Deposit shall be returned upon disconnection less any monies owed.
6. A reconnection charge of \$25.00 shall be paid by customers who request to be Disconnected and reestablish service within 12 months.
7. A service charge of \$40.00 for return checks.
8. A service charge of \$50.00 for field collections
