

AMENDMENT TO AGREEMENT

This Amendment to Agreement, made and entered into this 1st day of December, 1989, by and between COLUMBIA GAS OF KENTUCKY, INC. (Columbia), a Kentucky corporation, and TOYOTA MANUFACTURING, U.S.A., INC. (Toyota), a Kentucky corporation.

WITNESSETH:

WHEREAS, Columbia and Toyota entered into a Gas Service Agreement dated October 24, 1986, under which Columbia agreed to sell and to deliver specified volumes of gas to Toyota through October 31, 1992. Said Agreement was approved by the Public Service Commission of Kentucky on February 12, 1987; and,

WHEREAS, Toyota desires to increase its Firm Daily Volumes and decrease its Interruptible Daily Volumes for the duration of the Agreement; and,

WHEREAS, Columbia is willing to accommodate Toyota's request for additional gas volumes under said Agreement.

NOW, THEREFORE, in consideration of the premises, the parties hereto agree that that certain Agreement between them, dated October 24, 1986, shall be and is hereby amended and modified as follows:

1. Section 1.1(B) shall be amended to provide that:

(B) November 1, 1987 - November 30, 1989

Firm Daily Volume	2,600 Mcf
Interruptible Daily Volume	up to 7,800 Mcf
Maximum Daily Volume	up to 10,400 Mcf

2. Section 1.1(C) shall be added, and provides that:

(C) December 1, 1989 - October 31, 1992

Firm Daily Volume	5,300 Mcf
Interruptible Daily Volume	up to 7,700 Mcf
Maximum Daily Volume	up to 13,000 Mcf

This Amendment to Agreement is expressly contingent upon the receipt of approval of this Amendment of Agreement by the Public Service Commission of Kentucky, and in the event such approval is terminated or withdrawn, then this Amendment to Agreement shall terminate.

In all other respects and as to all its other terms and conditions, said Agreement dated October 24, 1986, shall remain in full force and effect.




