<u>Clinton County Customers Monthly Surcharge</u> – A monthly surcharge of \$0.24 per Mcf will be added to all customer bills effective July 1, 2020 through June 30, 2030. The purpose of the surcharge is to pass on increased wholesale gas costs authorized by the Federal Energy Regulatory Commission in Docket No. PR17-54-000. The surcharge was approved by the Kentucky Public Service Commission in Case No. 2019-00430.

Refund to Johnson County Gas and B&H Gas Customers Pursuant to Case No. 2020-00396 – The following refunds shall be paid by Navitas KY NG as denoted in the Apr8il 27, 2021 Order in Case No. 2020-00396.

Refund to Johnson County Customers – In Case No. 2020-00122, the KY Commission found that Johnson County Gas ("JCG") owed its customers a refund. Pursuant to the April 27, 2021, Order in Case No. 2020-00396, whereby Navitas KY NG has acquired the JCG systems, Navitas KY NG shall refund to its Johnson County customers \$9,450. This refund shall be issued over a period of 36 months to its customers, which will result in repayment of \$1.00 per customer, per month for 36 months.
