This schedule of Rules and Regulations governs the furnishing of sewage service to the area formerly served by Bullitt Utilities, Inc., dba Hunters Hollow Sewer Plant but now being served by Bullitt County Sanitation District hereinafter referred to as the Utility and applies to all service received from the Utility. No employee or individual director of the Utility is permitted to make an exception to these Rates, Rules, or Regulations. All Rules and Regulations are to be in effect so long as they are not in conflict with Public Service Commission Rules and Regulations. The utility is further subject to all Rules and Regulations of the Commission even though not contained herein.

REVISIONS

These Rules and Regulations may be revised, amended, supplemented or otherwise changed from time to time subject to approval of the Public Service Commission, and shall have the same force as the present Rules and Regulations.

SERVICE AREA

The utility furnishes sewage service to Hunters Hollow Subdivision and adjoining area in Southern Jefferson County and Northern Bullitt County near Louisville, Kentucky.

AVAILABILITY

Sewer service is available to any domestic, commercial, or industrial consumer within the Utility's area.

SUBSTANCES NOT TO BE DISCHARGED INTO SEWERS

No substances shall be placed or discharged into the sanitary sewer system which will create a combustible, gaseous, explosive or inflammable condition in such sewer system nor shall any substances or objects be placed or discharged into the sewer system which will not dissolve and which will thus cause an obstruction and clogging within the system. No petroleum products shall be placed or discharged into the sewer or surface water drain shall be connected with the sanitary sewer system nor shall any storm or surface water be otherwise introduced into the sewer system.

WASTE ACCEPTABLE INTO SEWERS

Only normal domestic waste (sewage) with a 5 day B.O.D. not to exceed 250 mg/l is acceptable.

SEWER FAILURE

The Utility is responsible for sewer failure only when in control of the Utility's employees. No consumer is paid damages for equipment unless such damages are specifically found to be caused by an act of negligence on the part of the Utility or its employees.

PROTECTION BY CONSUMER

Consumer shall protect the equipment of the Utility on his premises and shall not interfere with Utility's property or permit interference except by duly authorized representatives of the Utility.

NOTICE OF TROUBLE

Consumer shall give immediate notice to the Utility of any irregularities or unsatisfactory service and of any defects known to consumer.

MAINTENANCE

The Utility may at any time deemed necessary, suspend sewer service to any consumer or consumers for the purpose of making repairs, changes or improvements upon any part of its system. The Utility shall give reasonable notice of such suspension of service to the consumer.

LINE RELOCATIONS

When necessary to move or relocate facilities, the cost will be paid by the party or parties requesting such relocation.

BILLING, COLLECTION, FEES

Billing for sewage service furnished by the sewer system shall be made by the Louisville Water Company on its regular monthly water bills, and each such bill shall be subject to the schedule for payment imposed by Bullitt County Sanitation District according to its applicable Rules.

In the event that a complaint is filed in court to collect the amount the consumer owes the Utility, the Utility shall also be entitled to recover from the consumer the amount due plus any court costs awarded by the Court of jurisdiction.

SPECIAL NON-RECURRING CHARGE DESCRIPTIONS

1. Late Payment Charge

A late payment charge will be assessed on any account not paid by the due date, which shall be no sooner than 20-days from the original mailing date of the bill. The charge may be assessed only once on any bill for rendered services. Any payment received shall first be applied to the bill for service rendered. Additional penalty charges shall not be assessed on unpaid penalty charges.

2. Returned Check Charge

A returned check charge will be assessed when a customer's check is returned, either due to insufficient funds, or other reason due to customer fault.

OTHER

Bullitt County Sanitation District adopts all applicable Commission regulations for all instances not covered by the regulations of the Utility.
