# 1.1 <u>APPLICATIONS</u>

## 1.1.1 GENERAL

- A. This tariff contains the regulations and rates applicable to :
  - Interoffice private line services furnished between and within Kentucky Data Link (KDL) Point(s) of Presence (POP) in the State of Kentucky for intrastate communications,
  - Private Line Local Channel Services which connect customer premises to KDL POP for use with interoffice channels provided under this tariff,
  - Access coordination function(s) on Local Channels provided by the customer which are equivalent of those offered herein.

Private line services are provided by Kentucky Data Link Inc.( herein referred to as "KDL" or "the Company").

1.1.2 Jurisdiction -Jurisdiction refers to the classification of a private line service as intrastate (subject to the jurisdiction of the Kentucky State Public Service Commission) or as Interstate ( subject to the jurisdiction of the Federal Communications Commission)

### RULES AND REGULATIONS

# 2.1 UNDERTAKING OF KDL

2.1.1 General - A private line service is furnished for the transmission of communications. It may include one or more interoffice and/or local channels, central office connections office functions, miscellaneous functions, miscellaneous equipment, and channel options. A private line service may also consist solely of a central office connection or solely of an office function.

Private line services are provided on a monthly basis.

KDL is responsible for end-to-end service between a customer's premises when (1) a private line service uses the Access Coordination Function and a Local Channel, or (2) a private line service uses the Access Coordination Function and other access. Service dates of components may be independent of each other when the customer obtains access other than that furnished under the Local Channel sections of this Tariff.

KDL does not transmit messages. However, the private line facilities it furnishes may be used for that purpose.

- 2.1.2 Transmission Medium KDL selects and/or arranges for the facilities and/or equipment used to provide a private line service. KDL may modify or change the facilities and/or equipment at any time subject to the regulations in 2.3.2 following. Any suitable technology or combination of technologies may be used.
- 2.1.3 Provision of Private Line Services The services offered under this Tariff are subject to the availability of suitable facilities and equipment.
  - A. Engineering, Installation, and Maintenance KDL fully supports the private line services provided under this Tariff through engineering, installation, and maintenance efforts. KDL will ensure that each private line service functions properly within its specified transmissionservice COMMISSION signaling, or switching parameters. OF KENTUCKY EFFECTIVE

2.1 UNDERTAKING OF KDL (Cont'd)

2.1.3 Provision of Private Line Services (Cont'd)

- Engineering KDL will engineer a private line service to meet transmission parameters and/or equipment specifications.
- 2. Installation KDL will schedule installation activity to meet the due date of the private line service. If the customer's request that installation activity be performed at other than KDL's scheduled time results in premium payment for labor, additional charges will apply.

The local channels provided under this Tariff (a) will include any entrance cable or drop wiring and wire in intrabuilding cable to that point where provision is made for termination of the LEC's outside distribution network facilities at a suitable location inside a customer's premises and (b) will be installed to such point of termination. Where available through the LEC, wire required within a building to extend the point of local channel termination will be provided, at the customer's request, at rates for such installation which are the same as those listed in the appropriate section of the related LEC's tariff from which access is obtained.

3. Maintenance - KDL will maintain and repair, or arrange for the maintenance and repair of only the private line service which it provides. The testing of a service which is routed through a KDL POP will be made from that office.

# 2.1 UNDERTAKING OF KDL (Cont'd)

If a trouble condition occurs, the customer is responsible for determining if the trouble is in any customer equipment or customer-provided communications system which is connected at the customer's premises. A Maintenance of Service Charge will apply if, at the customer's request, a repair person is dispatched to the customer premises and testing discloses that the private line service is functioning correctly. No charge will apply, however, if at a later time the trouble condition is actually determined to be a malfunction of any KDL-provided private line service.

- 2.1.4 Through Transmission of Signals KDL is responsible for the quality of transmission and signaling on the private line services it provides.
- 1.5 Limitations on the Provision of a Private Line Service
  - A. Availability A private line service is offered subject to the availability of the facilities and equipment required to provide the service. If a shortage of these components exists, the installation of those required to furnish KPLN Service (Kentucky Private Line Network) will take precedence.

KDL bases the rates and charges quoted in this Tariff on services furnished under normal conditions. Where installation of facilities involves unusual costs because of factors such as the time period, type of facility or location requested by the customer, special construction charges based on maintenance, operation, depreciation, engineering, return on investment and other expenses associated with furnishing the service may apply. Special Construction charges may consist of recurring charges, nonrecurring charges, or both. Special Construction charges may also include termination charges. **PUBLIC SERVICE COMMISSION**

# 2.1 UNDERTAKING OF KDL (Cont'd)

Special equipment and arrangements not otherwise provided in this Tariff will be provided on an individual case basis. These services will be provided only if KDL deems them to be practical, and only if the special equipment or arrangement is in accord with and used in connection with other services provided by KDL. Charges for these services will be based on the estimated service costs including maintenance, operation, depreciation, administration, taxes, and other service specific costs, and a reasonable amount for return and contingencies.

- B. Restoration of Private Line Services In the event of failure, private line services will be restored.
- C. Hazardous Locations Service will not be furnished at a location that KDL considers hazardous (e.g. explosive atmosphere environments). In such cases, KDL, if so requested, may terminate the facilities at a mutually agreeable alternate location. The customer will then be responsible for extension to the hazardous location.
- D. Services offered under this Tariff will be provided only if billing capabilities for the services exist.
- 2.1.6 Transfer or Assignment A private line service may be transferred or assigned to a new customer, provided that:
  - A. The customer of record (former customer) requests in writing that KDL transfer or assign the private line service to the new customer.

- 2.1 UNDERTAKING OF KDL (Cont'd)
  - B. The new customer notifies KDL in writing that it agrees to assume all obligations of the former customer at the time of transfer or assignment. These obligations include: (1) all outstanding indebtedness for the private line service, (2) the unexpired portion of any applicable minimum payment period(s), and (3) any applicable termination liability(ies).
  - C. The private line service is not interrupted or relocated at the time the transfer or assignment is made.
  - D. KDL acknowledges the transfer or assignment in writing. The acknowledgment will be made within 15 days of receipt of notification.

The transfer or assignment does not relieve or discharge the former customer from remaining jointly and severally liable with the new customer for any obligations existing at the time of transfer or assignment. These obligations include: (1) all outstanding indebtedness for the private line service, (2) the unexpired portion of any applicable minimum payment period(s), and (3) any applicable termination liability(ies).

- 2.2 USE
- 2.2.1 General A private line service may be used for any purpose permitted by law.
- 2.2.2 Resale or Shared Use When a private line service is resold or shared, the customer may advise its user that a portion of its service is provided by KDL. However, the customer shall not represent that KDL jointly participates with the customer in the provision of its services.

# 2.2 USE (Cont'd)

- 2.2.3 Interference, Impairment, and Hazard The customer's use of a private line service must not interfere with, or impair, any services provided by KDL to others. In addition, it must not endanger the safety of installation/maintenance personnel or the public; damage or interfere with the functioning of KDL equipment or service; or otherwise injure the public in its use of these offerings.
- 2.3 RESPONSIBILITIES OF KDL
- 2.3.1 Liability
  - A. KDL's liability, if any, for its willful misconduct is not limited by this Tariff. With respect to any other claim or suit, by a customer or by any others, for damages associated with the installation, provision, termination, maintenance, repair, or restoration of a private line service, and subject to the provisions of B. through H. following, KDL's liability, if any, shall not exceed an amount equal to the proportionate charge provided for under this Tariff for the private line service for the period during which the service was affected.
  - B. KDL is not liable for damages associated with service, channels, or equipment which it does not furnish.
  - C. KDL is not liable for any act or omission of any other carrier providing a portion of a private line service, nor shall KDL for its own act or omission hold liable any other carrier providing a portion of a private line service.
  - D. KDL is not liable for damages to a premises resulting from the furnishing of service including the installation and removal of equipment and associated wiring, unless the damage is caused by KDL's negligence.
  - E. KDL shall be indemnified, defended and held harmless by the customer and user against all claims, losses, or damages arising from the use of private line services furnished pursuant to this Tariff, involving:

- 2.3 RESPONSIBILITIES OF KDL (Cont'd)
  - 1. Claims for libel, slander, invasion of privacy, or infringement of copyright arising from any communication;
  - 2. Claims for patent infringement arising from combining or using the private line service furnished by KDL in connection with facilities or equipment furnished by others; or
  - 3. All other claims arising out of any act or omission of others relating to private line services provided pursuant to this Tariff.
- 2.3.1 Liability (Cont'd)
  - F. No license under patents (other than the limited license to use) is granted by KDL or shall be implied or arise by estoppel, with respect to any private line service offered under this Tariff. KDL will defend the customer and user against claims of patent infringement arising solely from the use by the customer or user of private line services offered under this Tariff and will indemnify such customer or user for any damages awarded based solely on such claims.
  - G. KDL's failure to provide or maintain private line services under this Tariff shall be excused by labor difficulties, governmental orders, civil commotions, natural catastrophes, and other circumstances beyond KDL's reasonable control, subject to the provisions for Credit Allowances for Interruptions in this Tariff.
  - H. KDL does not guarantee or make any warranty with respect to its local channel services when used in an explosive atmosphere. KDL shall be indemnified, defended, and held harmless by the customer and user against all claims, losses, or damages by any person relating to the services provided pursuant to this Tariff when used in an explosive atmosphere.

## 2.3 RESPONSIBILITIES OF KDL (Cont'd)

- 2.3.2 Changes in Minimum Protection Criteria, Facilities, or Procedures: KDL is not responsible to any party if a change in a local channel service's Minimum Protection Criteria, facilities, operations or procedures (1) affects any facilities, customer equipment or customer-provided communications system in any way, or (2) requires their modification in order to be used. However, if such changes can be reasonably expected to materially affect the operating or transmission characteristics of the KDL Service, or render any customer equipment or customer-provided communications system incompatible, KDL will provide adequate notice, in writing, to allow the customer an opportunity to maintain uninterrupted service.
- 2.3.3 Service Dates When a customer orders a local channel service, all components of the resulting end-to-end arrangement which are provided by KDL will begin service on the same date, unless otherwise specified by the customer.
- 2.3.4 Registration Information KDL will make information available as required by Part 68 of the FCC's Rules and Regulations (e.g., the number of ringers that may be connected to a particular local channel service).
- 2.4 RESPONSIBILITIES OF THE CUSTOMER
- 2.4.1 General The customer's general responsibilities are described in this section. When other access is connected to a private line service, the customer assumes additional responsibilities that are described in the Connections section of this Tariff.
  - A. Placement of Orders, Payment of Bills, and Compliance with Regulations - The customer is responsible for placing orders, complying with Tariff regulations, and assuring that its users comply with Tariff regulations. The customer is also responsible for the payment of bills. The customer may appoint an agent to act on its behalf, as specified in B. following.

RESPONSIBILITIES OF THE CUSTOMER (Cont'd)

- 1. Information the Customer Must Provide When a customer places an order for service, the following information must be provided by the customer so that KDL can design, install, maintain, and bill the KDL service ordered:
  - The category of interoffice and local channel private line service, interface, and signaling (if required).
  - The KDL POP to which the local channel service is to be routed (when the customer elects to specify routing or when the local channel service consists solely of access coordination function),
  - The customer's billing name and address,
  - The contact name, telephone number, and address at each customer premise where the installation will be made,
  - The customer's desire to use LEC bridging (when a multipoint local channel service is ordered), and the location of Local Exchange Company bridges (when the customer elects to specify LEC bridge locations),
  - Information regarding customer equipment as specified in Part 68.106 of the FCC Rules and Regulations -(notification to telephone company),
  - The design information for other access when an order is placed to connect other access without the Access Coordination Function, and,
  - Exemption certification when the Special Access Surcharge set forth in 2.5.11, following, does not apply.

#### 2.4 RESPONSIBILITIES OF THE CUSTOMER (Cont'd)

- 2.4.1 General (Cont'd)
  - B. Agency Agreement KDL will accept orders from an agent appointed by the customer. An agency appointment must be sent to KDL in writing. If directed by the customer, the bill for the private line service will be sent to the agent and issued in the name of the customer, in care of the agent.

The customer retains responsibility for compliance with Tariff regulations and any act or omission of the agent, regardless of any limitations the customer may place on the agent's authority.

When the customer elects to order solely the access coordination function from KDL, the customer must give KDL written authorization to act on its behalf and is responsible for the access charges incurred.

C. Floor Space, Conduit, and Electrical Power at a Customer's Premises - The customer must provide the equipment space, supporting structure, conduit, and electrical power required to terminate a local channel service at a customer's premise without charge to KDL. The space, structure, conduit, and power must be made available in sufficient time to permit the installation of the local channel service to be completed prior to its due date. Selection of AC or DC power will be a matter of mutual agreement between the customer and KDL.

D. Access to Customer's Premises - The customer is responsible for arranging customer premises access at any reasonable time so that installation/maintenance personnel may install, repair, maintain, inspect, or remove a local channel service. Customer premises access must be made available at a time mutually agreeable to the customer and KDL.

# 2.4 RESPONSIBILITIES OF THE CUSTOMER (Cont'd)

- 2.4.1 General (Cont'd)
  - E. Locations Involving High Voltage Power When a customer orders a local channel service installed at a customer's premises where high voltage power is present, the customer shall:
    - 1. Install, maintain, and pay for special facilities and protective apparatus required by federal, state, or local regulations.
    - 2. Pay for required protective apparatus recommended for the location by KDL.
  - F. Availability for Maintenance, Testing, or Modifications The customer must make service available for maintenance, testing, or implementation of changes it has ordered, at any reasonable, mutually agreeable time. Occasionally an impairment may only be evident at certain times (e.g., a certain hour of the day). In such cases, the private line service must be made available for testing during the same time periods if the trouble condition is to be corrected.
  - G. Damage to a Private Line Service The customer must pay KDL for replacement or repair of a private line service when damage results from:
    - The negligence or willful act of the customer or others authorized by the customer,
    - Improper use of the private line service, or
    - Any use of equipment or systems provided by the customer or others authorized by the customer.

2.4 RESPONSIBILITIES OF THE CUSTOMER (Cont'd)

- 2.4.1 General (Cont'd)
  - H. Ancillary Charges The customer is responsible for the payment of any ancillary labor charges incurred, on its behalf, under tariffs of the local exchange companies, when the access coordination function is furnished.
  - Loss The customer must pay for the loss through theft of any local channel service equipment installed at a customer's premises.
  - J. Use with a Customer-Provided Communications System or With Services Provided by Others - When a local channel service is used with a customer-provided communications system, or with a service(s) provided by others via connections at the customer's premises, the customer must make all arrangements concerning the connected system or service with its provider. The connection does not constitute a joint undertaking between KDL and the provider of the system or service. Connections will be made in accordance with the regulations set forth in 2.7 following.
- 2.5 PAYMENTS AND CHARGES
- 2.5.1 General The charge for service may be a recurring and/or a nonrecurring charge.
- 2.5.2 Application of Charges The charges billed are based on the rates that are in effect in this Tariff during the period that the service is furnished. If the rates for a period covered by a bill change after the bill has been rendered, the bill will be adjusted to reflect the new charges.

- 2.5 PAYMENTS AND CHARGES (Cont'd)
- 2.5.3 Payment of Charges Payment is due upon presentation of a bill for the service furnished. A service may be discontinued for nonpayment of a bill.

An administrative charge of \$6.00 will be applied by KDL each time a check or bank draft is returned by a bank to KDL for the reason of insufficient funds.

- 2.5.4 Minimum Payment Period and Notice of Discontinuance
  - A. Minimum Payment Period The minimum payment period is the minimum period for which the customer is required to make payment for the service. The charges applicable to the minimum payment period include the recurring charge(s) plus any nonrecurring and/or special construction charge(s) that may apply.

The minimum payment period is calculated for the date that billing started after (1) the initial installation, or (2) a reinstallation after a change.

Minimum payment period charges apply if the customer discontinues a private line service component before the specified minimum payment period expires. The minimum payment period for a given private line service component is specified in the section of this Tariff applicable to that private line service component.

B. Notice of Discontinuance - KDL requires notice when services are to be discontinued. The required notice period in the application of charges, if any, are specified in the section applicable to the specific service. (Under certain conditions, this notice requirement may be waived.)

# 2.5 PAYMENTS AND CHARGES (Cont'd)

- 2.5.5 Advance Payments and Deposits
  - A. Advance Payment An advance payment may be required before a service is provided when a customer has a history of late payments to KDL or when a customer's financial responsibility is not a matter of record. The advance payment will equal the charges for the minimum payment period and the applicable nonrecurring charges. In addition, the advance payment will include an amount equal to the estimated nonrecurring charges and one month's recurring charges (if any) when special construction is involved. The advance payment will be credited on the customer's bill(s). A deposit may apply in addition to an advance payment.
  - B. Deposits To safeguard its interests, KDL may require a customer with a history of late payments to KDL or whose financial responsibility is not a matter of record to make a deposit to be held as a guarantee for the payment of charges. A deposit does not relieve the customer of the responsibility for the prompt payment of bills on presentation. The deposit will not exceed an amount equal to the sum of the charges for the minimum payment period for the service.

If a termination charge or a maximum termination liability is specified, the deposit may include an additional amount. This additional amount will not exceed the maximum charge(s) specified for the termination charge or maximum termination liability.

An advance payment may be required in addition to a deposit.

- 1. Interest on a Cash Deposit Simple interest at the rate of 6% per annum shall be credited or paid to the customer while the deposit is held by KDL.
- 2. - 2.5.6 Types of Charges There are two types of charges, recurring and nonrecurring. These charges are as follows:
  - A. Recurring Charges The recurring charges for services are listed in the applicable service section as:
    - 1. Monthly Charge A monthly charge applies each month or fraction thereof that service is furnished. Monthly charges start on the day after the service is installed, but not before the due date of the order unless the customer agrees to an earlier installation. Charges accrue through and include the day that the service is discontinued. Monthly charges will be billed in advance. When the billing date and the date that the service is started, changed or discontinued do not coincide, the charges will be adjusted to reflect the fractional part of the month involved. For billing purposes, each month is considered to have 30 days.
  - B. Nonrecurring Charges A nonrecurring charge applies for an activity, such as an installation, a move, or a change, ordered by the customer. A nonrecurring charge applies for each activity performed. The charge may differ according to the work activity involved. Other charges, such as termination charges, if applicable, are also classified as nonrecurring charges. In addition, other charges for specific functions as stated in this Tariff are applied on a nonrecurring basis. Following is a description of the generic nonrecurring charges.
  - 1. Installation Charge An installation charge applies when service is furnished. Installation charges are listed in the appropriate sections of this Tariff. Installation charges may be further categorized as follows:

When a component with a termination charge is moved, the customer must pay the unexpired portion of the termination charge. A new termination charge will be established at the new location.

A move normally involves an interruption of the service for the period required to complete the move. No credit allowance will be granted for the period.

When a customer requests the installation of a duplicate service to avoid interruption during a move, recurring and nonrecurring charges will apply for the duplicate service. A move charge is equal to one-half of the installation charge for the local channel service involved, including the access coordination function and any channel options, miscellaneous equipment and arrangements that are associated with the service at that building.
  - B. Nonrecurring Charges (Cont'd)

The termination charge is determined by multiplying the dollar amount by the ratio of the unexpired portion of the specified period of time. Various special routing options are available for Interoffice Voice Grade Services. These special routing options have associated charges in addition to other applicable charges. If complete Special Routing is not available when ordered, or if it becomes unavailable at a later date due to network rearrangements, Special Routing may only be furnished on a partial basis. The customer will be advised before partial Special Routing is provided and may cancel the order or discontinue the Special Routing if the partial Special Routing is not acceptable. No cancellation charge will apply in such cases. The customer options for special routing are:

-Diversity -Avoidance

Special Routing is furnished subject to the availability of channel components.

- Diversity Two or more channels are furnished partially or entirely over not more than two physically separated routes, subject to availability of facilities.
- 2. Avoidance A service is furnished over a channel that avoids a specified geographic location. Avoidance is offered subject to availability of alternate route facilities.

- 3.2 VOICE GRADE LOCAL CHANNEL SERVICE- A Voice Grade Local Channel Service provides for the transmission of analog signals within a frequency bandwidth of approximately 300 to 3000 Hz.
- 3.2.1 Description A Voice Grade Local Channel Service is suitable for transmission in one direction (one-way) or transmission in two directions (two-way) of voice, data or any other application required by the customer which utilizes analog signals within the specified transmission parameters of the local channel.

A Voice Grade Local Channel Service is provided (1) between one or more customer premises and an KDL POP or (2) solely as an access coordination function(s).

Multipoint local channel services are normally bridged at the KDL POP. Subsequent to the effective date of this tariff, KDL will at the customer's request, design its service to multiple customer premises within a LATA via the use of a bridge(s) located at a Local Exchange Company wire center(s). The customer may request specific LEC bridging locations, or may alternately request KDL to employ LEC bridging to the extent it deems practical using good engineering judgement. However, if KDL determines that it is unable to meet service design and technical performance criteria in the configuration requested, the customer will be advised and given the opportunity to cancel or change the order. In such cases, no charge will apply for the cancellation in the customer's order.

Examples of technical considerations are:

- generally data circuits will not perform satisfactorily with more than two interbridge circuit links in tandem.
- KDL's ability to test and restore circuits is diminished when bridging occurs outside its central offices. This is particularly severe when bridges are connected in tandem outside its POP.

When KDL bridging is employed to provide a multipoint local channel service, the local channel is billed via the local channel offering set forth in Section 3.3.1 following.

B. Signaling - Signaling is the process by which one location alerts another location on the same channel or network that it wishes to communicate.

The signaling arrangements available permit signals generated by other equipment at a location to be transmitted over a local channel service. They do not include the capability to initiate or receive those signals.

The signaling arrangement to be used on a local channel service is dependent on the type of equipment connected to the local channel service, the function of the channel (e.g., off-premises station, foreign exchange, tie trunk) and the manner in which the customer wants the signal process to operate (e.g., ringdown, dial).

(a) Loop Start Loop Signaling - Loop start loop signaling is used for off-premises stations, trunk to station tie lines, and other channels which are terminated in switching equipment at one end and other terminal equipment (e.g., in a handset) at the other end. The interface with the switching equipment is referred to as the open end and the interface with the station is referred to as the closed end.

This signaling arrangement is designed to pass an open loop (idle condition) or closed loop (seized condition) from the station to the switching equipment. It will transmit dial pulse of multifrequency pulsing signals from the station to the switching equipment and dial tone and 20 Hertz ringing from the switching equipment to the station.

(b) Ground Start Loop Signaling - This signaling arrangement is used for channels that interface with central office switching equipment on the open end and PBX on the closed end to provide a PBX to KDL trunk.

B. Signaling (Cont'd)

In the operation of this arrangement the closed end provides a closed loop and momentary ground for the ring conductor as a seizure. The open end provides a ground on the tip and battery on the ring as a seizure. This arrangement will transmit dial tone and 20 Hertz ringing from the open end to the closed end, and will transmit dial pulses or multifrequency pulsing address signals from the closed end to the open end.

- (c) E&M Signaling Interface This signaling arrangement is used for registered or grandfathered switching equipment tie trunks and is available as Type I, II, or III E&M Signaling.
- (d) Two-Point Automatic Ringdown Signaling Arrangements Loop Closure Interface - In this signaling arrangement, the calling station activates 20 Hertz ringing by providing a tip to ring conductor short as an off-hook signal. The 20 Hertz ringing operates a bell or relay at the distant station. Loop Closure interface is used for handset, key set, switchboard, and console terminations.
- (e) Manual Signaling Arrangements for Two-Point of Multipoint Local Channel Services 20 Hertz Interface - In this signaling arrangement the calling station transmits 20 Hertz ringing activated by the operation of a key or a button. The 20 Hertz ringing activates a bell or relay at the distant station. In the multipoint local channel service application, all stations receive the ring from the calling location.
- (f) Manual Signaling Arrangement with Code Selection for Multipoint Local Channel Services - This signaling arrangement is similar to the manual signaling arrangement for two-point local channels except that the calling station can select a single distant station or group of stations by keying one of nine predetermined codes.
