- If the Customer's service has been discontinued within the 12 months prior to any billing 2.8.4 date, or if the Customer incurs usage charges during a billing period which are equal to at least 200% of the amount ci the Customer deposit or guarantee, the Company may, by a telephone call to the Custo ner followed by written notification sent by first class mail, demand full payment within five (5) days of such notification.
