Applicable Within the Service area of Beech Grove Water Water System, Inc.

These rules and regulations are in addition to the rules of the Kentucky Public Service Commission

Any resident of Beech Grove Water System, Inc., is eligible for water service from the District.

A fee of \$10.00 shall be paid per membership.

A fee of \$10.00 will be charged for reinstalling of services.

One (1) week's notice must be given the company to discontinue service or change of occupancy.

Bills are due when rendered and delinquent after ten (10) days; if not paid within thirty (30) days, service may be discontinued by company.

Meters will be read and bills rendered monthly, but the company reserves the right to vary the dates or length of period covered.

Water connection and installation fees for each customer will be \$100.00 - \$200.00 after completion of construction.

A charge of \$1.00 will be made for each meter for each turn-on or cut-off, other than change of occupancy.

Service lines to meters and meters are property of the company. From meter to customer outlet installation and service will be sole responsibility of customer.

Credit/Debit Card Policy

All customers may pay their bill by credit or debit card. This method of payment may be made in person at the utility office, online, or by telephone. Customers must have the current month's bill to pay by telephone.

If on the bill due date an attempt to pay with a credit/debit card is made and the card is declined for any reason, payment is still due in full on that date and will be considered late on that date. All late charges will be applied. If a customer is paying on the disconnect day and the card is denied, the same rules as above apply, in addition to service being disconnected.

When a customer makes a payment by credit card, the processor (not the association) will assess a convenience fee for providing this service. Prior to processing the transactions, the customer will be informed of the fee amount.

ACH-Bank Draft/ Automatic Withdraw Policy

All customers may pay their bill by ACH-Bank Draft/Automatic Withdraw. The ACH-Bank Draft/Automatic Withdraw will be scheduled around the 5^{th} of each month. Between the 5^{th} and the 9^{th} of each month the payment will be processed. If for any reason payment is declined the payment will still be due by the 10^{th} of the month. All late charges and penalties will apply if payment is not made by the 10^{th} of the month.

In light of Ordinance Number 08132020-01 located in the Office of the McLean County Clerk, pertaining to fees collected by Water Utilities in order to fund County E-911, passed by the McLean Fiscal Court on September 10, 2020, Beech Grove Water Association adopts the following:

(N)

There shall be added to the customer's bill, listed as a separate line item, an amount equal to any fee, tax, assessment, etc., now or hereafter imposed by local legislative authorities, whether by ordinance, franchise or other means. Such amount shall be added exclusively to bills of customers receiving service within the territorial limits of the authority imposing the fee.

Where more than one such fee is imposed, each of the charges applicable to each customer shall be added to the customer's bill and listed as separate line items.

Where the local legislative authority imposes a flat, fixed amount on the active customers of the Beech Grove Water Association; the fee applied to the bills of active customers receiving service within the territorial boundaries of that authority, shall be in the form of a flat dollar amount. Beech Grove Water Association is just to act as a collection agent between the McLean County Fiscal Court and the active water customers.

The amount of such fee added to the customer's bill shall be determined in accordance with the terms of the ordinance, franchise or other directive agreed to by McLean County Water District.

A customer's payment will be applied in the following order of priority: amounts owed for current billing period; unpaid balance for water service provided in prior billing periods; and fees or taxes collected for other entities.

The utility may require a minimum cash deposit or other guaranty to secure payment of bills as set forth in 807 KAR 5:006 Section 7. Service may be refused or discontinued for failure to pay the required deposit.

All customers within a particular customer classification will pay equal deposits. The amount shall not exceed two-twelfths (2/12) of the average annual bill of customers within said classification where bills are rendered monthly.

Interest, as prescribed by KRS 278.460, will be paid annually either by refund or credit to the customer's bill, except that no refund or credit will be made if the customer's bill is delinquent on the anniversary date of the deposit.

Upon termination of service, the deposit, any principal amounts, and any interest earned and owing will be credited to the final bill with any remainder refunded to the customer.

If a deposit is held longer than 18 months, the deposit will be recalculated at the customer's request based on the customer's actual usage.

EXPLANATION OF SPECIAL CHARGES

- A. <u>Purpose</u>: Pursuant to the provisions of 807 KAR 5:006, Section 8, the District has adopted the following Special Charges to cover certain costs incurred for a specific customer. The purpose of these Special Charges is to keep from increasing rates to other customers who do not receive any benefits from the service provided or the action taken.
- B. Special Charges:
 - 1. <u>Turn-On Charge.</u> A Turn-On Charge shall be assessed for a new service Turn-On, seasonal Turn-On or temporary service. A Turn-On Charge shall not be made for initial installation of service where a tap-fee is applicable.
 - 2. Reconnect Charge. A Reconnect Charge shall be assessed to reconnect a service which has been terminated for non-payment of bills or violation of the District's Rules and Regulations or the Public Service Commission's Regulations.
 - 3. Termination or Field Collection Charge. A charge shall be assessed when a District representative makes a trip to the premises of a customer for the purpose of terminating service. The charge shall be assessed if the District representative actually terminates service or if, in the course of the trip, the customer pays the delinquent bill to avoid termination. The charge shall also be made if the District representative agrees to delay termination based on the customer's agreement to pay the delinquent bill by a specific date. The District shall make a Termination or Field Collection Charge only once in any billing period.

- 4. Meter Resetting Charge. A charge shall be assessed for resetting a meter if the meter has been removed at the customer's request.
- 5. Meter Test Charge This charge shall be assessed if a customer requests the meter be tested pursuant to Section 18 of 807 KAR 5:006 and the test shows the meter is not more than two percent (2%) fast. No charge shall be made if the test shows the meter is more than two percent (2%) fast.
- 6. Return Check Charge. A Returned Check Charge shall be assessed if a check accepted for payment of a water bill is not honored by the customer's financial institution.
- 7. <u>Late Payment Penalty</u>. A penalty shall be assessed if a customer fails to pay a bill for services by the due date shown on the customer's bill. The penalty shall be assessed only once on any bill for rendered services. Any payment received shall first be applied to the bill for service rendered. Additional penalty charges shall not be assessed on unpaid penalty charges.
- C. The amount of each Special Charge shall be the amount approved by the Public Service Commission. These amounts are set forth elsewhere in this Tariff.
