This agreement, entered into this 13th day of FEBRUARY, 1984, by and between Western Bracken County Water District, Rt. #1, Brooksville, Kentucky 41004, acting by and through its Commissioners, Vern ^{GLM}Galloway, chairman; Baxter Courts, ^{ABC}~~TREASURER~~ and Roy Reed, ^{RR}~~SECRETARY~~, hereinafter referred as TRANSFEROR, and Bracken County Water District #1, City Building, P.O. Box 201, Brooksville, Kentucky 41004, acting by and through its commissioners, Emery Lucas, chairman, James Fralix, secretary and Carson Rumford, treasurer, hereinafter called TRANSFEREE

witnesseth:

That, for and in consideration of the mutual covenants contained herein the parties agree as follows:

- 1.) Effective upon the date hereof, TRANSFEREE shall bear full responsibility for maintenance of a certain 4" water line from the gate valve at the present boundary of the two districts located on the Glenn Insko property on Goose Creek, to the pump house of TRANSFEROR in Perkins Ridge Road;
- 2.) TRANSFEREE shall have the right to install, maintain and read a master meter in or near said pump house of TRANSFEROR;
- 3.) TRANSFEROR grants, assigns and conveys to TRANSFEREE all its rights under all easements obtained by TRANSFEROR relative to the line involved herein.
