RULES AND REGULATIONS

The following Rules & Regulations are subject to change by the Water District Commissioners at any time, subject to Approval by the Public Service Commission.

1. Meters will be read monthly between the 20th & 25th of each month.
2. Bills will be dated & mailed by the first of each month (approximately). Said bills shall state that they are to be paid by the 20th of the month.
3. All meters will be located on district mains and in the absence of Special Permission on the Property to be served.
4. Complaints may be made to the operator of the system and may be appealed to the district commission.
5. The principle place of business of the district Water Office at Ghent, Kentucky.
6. Water bills may be paid at P.R. Simmons, residence Worthville, Ky. Sparta-Sanders State Bank, Sanders, Ky. or Tingle's Restaurant, Ghent, Ky.
