AMENDMENT TO WATER PURCHASE CONTRACT

THIS AMENDMENT TO WATER PURCHASE CONTRACT made and entered into this <u>16th</u> day of <u>April</u>, 1992, by and between the CITY OF COLUMBIA AND COLUMBIA UTILITIES COMMISSION of Columbia, Kentucky 42728, parties of the first part, and the ADAIR COUNTY WATER DISTRICT of Columbia, Kentucky 42728, party of the second part,

WITNESSETH:

WHEREAS, on June 11, 1982, the parties of the first part and the party of the second part have entered into a Contract whereby the parties of the first part was to furnish to the party of the second part water for resale purposes; and PUBLIC SERVICE COMMISSION OF KENTUCKY

WHEREAS, this Contract has been subsequently amend EFEGUVEncrease the costs of the water on different occasions; and SFP 22 1994

WHEREAS, the parties now desire to enter into an agreement to make PURSUANT 10 807 KAH 5011, SECTION 9 (1) BY: Queden C. Med.

NOW, THEREFORE, it is mutually agreed by and between the parties hereto as follows:

In Article A.I of the original Contract, the parties of the first part were furnishing water to the party of the second part, in a quantity not to exceed nine million gallons per month, with other provisions concerning leakage. This Contract is hereby amended to change the figure of nine million to ten million gallons per month.

The parties of the first part agree to furnish to the party of the second part a quantity of water not to exceed ten million gallons per month.

All of the remaining conditions and agreements contained in the original Contract, plus subsequent amendments, are hereby re-iterated and re-affirmed. This the 16th day of April , 1992.
