RULES AND REGULATIONS

The following rules and regulations are subject to change by the Garrard County Water Association, Inc. Board of Directors at any time, subject to approval by the Public Service Commission.

1. Meters will be read monthly between the 1st and 15th of each month.
2. Bills will be dated and mailed on the first of each month. Said bills will state that they are to be paid within 10 days.
3. All meters will be located on Association mains and in the absence of special permission on the property to be served.
4. Complaints may be made at the office of the Association and may be appealed to the Board of Directors of the Association.
5. The principal place of business of the Association is 207 Stanford Street, Lancaster, Kentucky.
6. Water bills may be paid at 207 Stanford Street, Lancaster, Kentucky.
