## AMENDMENT NO.2 TO WATER PURCHASE AGREEMENT

This Amendment No. 2 ("Amendment 2") to the Water Purchase Agreement dated May 15, 2012 as amended September 10, 2014, is entered into this 20th day of September, 2016 by and between:

And

HARDIN COUNTY WATER DISTRICT NO.1 A Water District Operating Pursuant to KRS Chapter 74 1400 Rogersville Road Radcliff, Kentucky 40160 ("HCWD1")

In consideration of the mutual terms and conditions contained herein below, the receipt and sufficiency of which is hereby acknowledged, LWC and HCWD1 (collectively the "Parties") agree to further amend the current Water Purchase Agreement between LWC and HCWD1 as follows:

Paragraph 1 of the amended Water Purchase Agreement is amended to add paragraph "g":

LWC desires to make and HCWD1 is willing to accommodate certain changes in the current design and construction of the master meter and vault as well as in the materials to be used for the pipeline traversing the Salt River. Such changes are intended to protect the master meter and vault from the adverse effects of periodic flooding and to otherwise improve the durability of the improvements. In order to facilitate the requested changes in construction and materials, LWC agrees to pay HCWD1: (1) the increased construction costs HCWD1 incurs in constructing the master meter and vault; (2) any difference HCWD1 incurs in material costs and; (3) any increased construction costs for change orders made necessary as a result of the proposed changes, if any. LWC further agrees to pay HCWD1 the aggregate sum of such additional costs in one payment. It is presently estimated that such additional construction costs will be approximately \$260,100.00 for the Salt River crossing change order. It is understood and agreed that there may be other change orders made necessary by reason of the requested changes.

PUBLIC SERVICE COMMISSION OF KENTUCKY Paragraph 5.b. of the current Water Purchase Agreement is amended as follows to add the following sentence to the beginning of the paragraph:

Notwithstanding the fact that the Parties agreed to install one 4 inch and one 6 inch pipeline servicing HCWD1, LWC agrees to charge and HCWD1 agrees to pay for wholesale water sales at a rate equivalent to the installation of three 4 inch pipelines.
