11. Discontinuance of Service of Customer

Any customer having fulfilled his contract terms and desiring to discontinue the water service to his premises for any reason must give notice of discontinuance in writing or in person at the business office of the District at least three (3) days prior to the date on which the customer desires to discontinue service. If such notice is not given, the customer shall remain liable for all water used and service rendered to such premises by the District until such notice is received by the District.

12. <u>Reconnection Fee</u>

Where the water supply to the customer has been discontinued for non-payment of delinquent bills, a charge of \$35.00 will be made for reconnection of water service, but the reconnection will not be made until all delinquent bills and other charges, if any, owed by the customer to the District have been paid.

13. Deposit

The District reserves the right to require that a nominal amount be placed on deposit with the District for the purpose of establishing or maintaining any customer's credit, such amount not to exceed two-twelfths (2/12) of the estimated annual bill of such customer. Upon the payment of such deposit, showing the name of the customer, the location of the initial premises occupied by the customer, and the date and amount of the deposit. Interest will be paid on all sums on deposit at the rate earned by the

30. Contributions In Aid Of Construction

The District may, at its option, accept contributions in did of construction including but not limited to customer financed extensions to its water system. In addition, such contributions in aid of construction may consist of cash donations, in any amount, which the District may, at its option, apply to expenses of an extension or other projects. The acceptance by the District of contributions in aid of construction entitles no one to a refund and none shall be made.

31. <u>Taps and Connections</u>

All taps and connections to the mains of the District shall be made by and/or under the supervision and direction of District personnel.

32. <u>Returned Check Charge</u>

A \$35.00 charge shall be levied and paid by the customer to the District on each check of [I] the customer "returned" for whatever reason.
