RATES & CHARGES

SCHEDULE OF SPECIAL SERVICE CHARGES

- 1. Meter Reading Recheck Charge. A charge of \$58.00 shall be made for a trip to recheck a meter reading when the customer requests the meter to be rechecked for a correct reading and the meter was not misread. (I)
- 2. Service Reconnection Charge. During regular work hours, a reconnect charge of \$58.00 is required for the reconnection of a meter that has been disconnected for failure to pay bills. (I)
- 3. Meter Test. Upon request and payment of \$135.00, a customer may have his/her meter tested, provided request by the customer is not more frequent than once each twelve months. If such test shows the meter to be more than two percent fast, a refund of the \$135.00 charge shall be made and the bill adjusted accordingly. If the periodic testing requirements of 807 KAR 5:066, Section 16 have not been met for meter testing, no charge will be made for the test regardless of the results of the test. (D)
- 4. PSC Meter Test Complaint. Any customer of the Association may request a meter test by written application to the Kentucky Public Service Commission. (I)
- 5. Returned Check Charge. A charge of \$20.00 shall be made when a check is returned by the bank. (T)
- 6. Service Charge. There will be a \$58.00 service charge to transfer an account, or open an account on an existing service. (I)
- 7. Residential Customer Deposit. \$73.00.
- 8. Commercial Deposit. \$66.00.
- 9. Meter Installation. (5/8" x 3/4" meter install.) \$1,156.00

- 10. A late payment charge of 10% will be added to all unpaid bills after the 10th day of the month. The late payment charge may be assessed only once on any bill for rendered services. Additional late payment charges shall not be assessed on unpaid late payment charges. (T)
