RULES AND R	EGULATIONS

The following rules and regulations are subject to change by the water association commissioners at any time subject to approval by the Public Service Commission of Kentucky.

- 1.) The association will impose a penalty of 10% on all bills not paid by the 10th of the month.
- 2.) When a customer's meter is found to be inoperative the association will use the average of the preceding three months to compute the customer's bill.
- 3.) All water meters will be read on the 20th, 21st, 22nd, 23rd and 24th of each month, weather permitting.
- 4.) A deposit not to exceed \$25.00 is required from persons who are renting from members of the association and interest at the rate of 6% will be paid on demand on all deposits.
- All customers will be billed in accordance with the rate schedule of the association.
- 6.) The office of the association is located at 116 E. Main Street, Burgin, Kentucky 40310 and the office hours are from 8:30 a.m. to 1:00 p.m. Tuesday thru Saturday. The office will be closed on Mondays.
- 7.) Water usage for each member is computed each year, based on total dollars water sold related to profit or loss, and recorded on each members accounts receivable ledger sheet.
- 8.) New members of the association will pay a tap fee of \$300.00 for water (I) service.
