The failure of the customer to pay water charges duly imposed by the District shall result in the automatic imposition of the following penalties;

- 1. Payments received after the 15th of each month shall be subject to a 10% penalty.
- 2. If payment is not received by the 25th of the month, the customer's service will be disconnected.
- 3. In the event it becomes necessary for the District to disconnect the customer's service. A \$40.00 disconnection charge and a fee of \$40.00 will be charged for reconnection of the service within office hours. Upon customer request, and subject to availability of maintenance staff, services may be reconnected outside regular working hours at the after-hours rate of \$90.00
