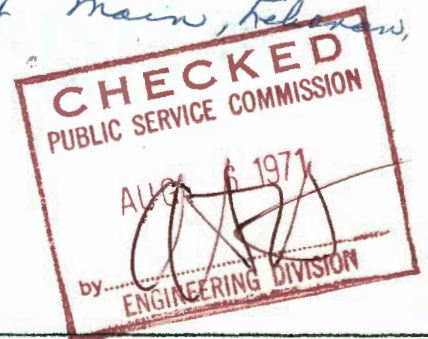

 - 2- Bills will be dated and mailed on 29th - 30th or 31st, of each month. Said bill will state that they are due upon receipt. Service will be cut off 15th if not paid.
