All applications for service shall be accompanied by a \$10.00 deposit, except house trailer deposits shall be \$15.00.

A fee of \$5.00 will be charged for disconnection and reconnection.

No customer shall resell water except under terms of a special contract with the District.

Meters shall be read each month commencing on the 15th day.

Service lines to meters and meters are property of the District. From met to customer outlet, installation and service shall be the sole responsibility of customer.
