This agreement made and entered into at Kenton County, Kentucky, this <u>23</u> day of September, 1984, by and between the <u>CITY OF TAYLOR MILL</u>. KENTUCKY, a city of the <u>fifth</u> class, hereinafter designated "Party of the First Part" or "City" and KENTON COUNTY WATER DISTRICT NO. 1, a public corporation created under Chapter 74 of the Kentucky Revised Statutes, hereinafter referred to as "Party of the Second Part" or "District", WITNESSETH:

WHEREAS, the parties hereto are desirous of reaching an agreement for service and maintenance of the water system of the Party of the First Part, and said work to be furnished by the Party of the Second Part, they do hereby agree as follows:

1) The District shall have available for the use of the City the District's emergency service number to receive after-hour calls from Taylor Mill water customers and, in order to help defray the cost of readiness to respond to emergency repairs including equipment, maintenance, material storage, and for administrative costs associated with the above, the City of Taylor Mill agrees to pay the District the sum of One Hundred (\$100.00) Dollars per month.

2) All other services performed by the District for the City will be charged by the District to the City at the current rates. This includes water sampling and repair service, which shall be at cost, plus 10%. This supersedes all previous agreements between the parties. The foregoing services will be provided only and shall be at the request of the City.

3) This contract shall be on an annual basis from November 1, 1984, for a one year period. It shall automatically be renewed on an annual basis unless either party notifies the other party in writing by October 1 that it wishes to terminate this agreement.

4) The District shall bill the City at the end of each month and said statement for the preceding month shall be paid by the City by the 20th of the following month after the services were rendered.

IN WITNESS WHEREOF, the parties have hereunto set their hands the date first herein written.
