Special Non-Recurring Charges:

The District will uniformly collect for special nonrecurring charges to recover customer-specific costs incurred which would otherwise result in monetary loss to the District or increased rates to other customers to whom no benefit accrues from the service provided or action taken. (T)

Regular Working Hours for the District are 8:00 a.m. to 4:00 p.m. Monday through Friday, excluding holidays. Upon customer request and subject to the availability of appropriate staff, services may be performed outside regular working hours at the After-Hours Charge rate. (N)

1. Connection/Turn-on Charge: Will be assessed for new service turn-ons, seasonal turn-ons, or temporary service. The Charge will not be made for initial installation of service where a Meter Connection/Tap-on Charge is applicable.

2. Connection/Turn-on Charge (After Hours): Will be assessed anytime this service is provided outside of normal working hours at the customer's request. (N)

3. Field Collection Charge: Will be assessed when a District representative visits the premises of the service connection to terminate service, and the customer is on-site and pays the bill to avoid termination of service. This fee may only be charged once per billing period. (T)

4. Late Payment Charge: Will be assessed on the delinquent amount of the (T) bill, less taxes.

5. Meter Relocation Charge: Will be assessed when a customer or other (T) authorized person requests that a meter be relocated, changed, or modified. Those requesting a change must reimburse the District for the actual costs incurred, including but not limited to appropriate legal, administrative, engineering, overhead and related costs.

6. Meter Re-read Charge: Will be assessed when a customer requests the (T) District to re-read the customer’s meter and the re-read proves that the original meter reading was correct.

7. Meter Test Charge: Will be assessed when a customer requests the (T) District perform a test on the customer’s meter to check for accuracy, and the test shows the customer’s meter is not more than two percent (2%) fast.

8. Reconnection Charge: Will be assessed to reconnect service that has (T) been terminated for non-payment of service or for a violation of District or Public Service Commission rules and regulations.

9. Reconnection Charge (After Hours) Will be assessed anytime this (N) service is provided outside of normal working hours at the customer’s request.

Meter Reading & Billing Procedure

The Oldham County Water District, a water district organized pursuant to Chapter 74 of the Kentucky Revised Statutes, will make the following changes for meter reading and sending bills:

Meters will be read and billed monthly. However due to bad weather or reason beyond the Water District's control when meter can not be read, customers will receive an estimated bill base on the previous three month period. The bill will be coded with an (E) to let the customer known it is an estimated bill.

The billing computer will be programmed to signal if the present reading is unusually much higher than the previous month and adjust accordingly.

Bill Payment

Customers may make payment by cash, check, automated clearing house (ACH), credit or debit card and electronic transfer applications listed on the District’s website or posted at the District’s office. Customers making payment by credit or debit card or by other electronic transfer applications may be assessed a fee by the payment processor to complete the transaction. Prior to completion of such transaction, Customers will be advised of any transaction fee and afforded an opportunity to cancel the transaction.

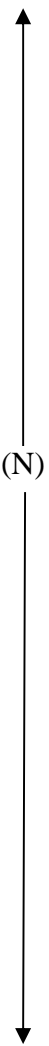
The transactions must be completed before the due date listed on the Customer’s bill to avoid the assessment of a late payment fee.

If a Customer renders payment to the District by check or any form of electronic funds transfer and the check or transfer is not honored upon deposit by the District, the Customer will be charged the Returned Check Charge referenced in the Special Non-Recurring Charges contained in the District’s filed tariff.

Electronic Billing (“Paperless Billing”)

Billing statements and notices will be mailed via the U.S. Postal Service to Customer at the address set forth in the application unless the Customer notifies the District verbally by telephone or in person to an authorized District Customer Representative or in writing or online via the Customer Portal on the District’s website of a different address to mail such statements and notices.

Customers may enroll in Paperless Billing to receive a bill in electronic form by electronic mail in lieu of a paper bill. By enrolling in paperless billing, the Customer consents to waiver of Customer’s right under 807 KAR 5:006 to receive billing statements and notices by mail except notice of termination, the process of which is described below. If the District intends to terminate service of a Customer enrolled in Paperless Billing and the District’s Rules and Regulations or 807 KAR 5:006 requires advanced written notice of the termination of service, the District will

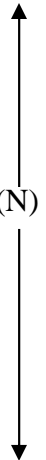

When enrolling in Paperless Billing, Customers must designate the electronic mail address to which all billing statements and notices will be transmitted. Customers are responsible for providing the correct electronic mail address and notifying the District of any changes in the Customer's electronic mail address. Customers are also responsible for managing their electronic communication devices. REIMBURSEMENT TO CUSTOMERS CONTRIBUTING TO EXTENSIONS & REGARDS TO NEW SUBDIVISIONS

The Oldham County Water District, a water district organized pursuant to Chapter 74 of the Kentucky Revised Statutes, will make the following changes on reimbursement to customers contributing to extensions and in regards to new subdivisions.

For a period of five (5) years after construction of the extension, each additional customer whose service line is directly connected to the extension installed, and not to extensions or laterals therefrom, shall be required to contribute to the cost of the extension based on a recomputation of both the utility's portion of the total cost and the amount contributed by the customers. The utility shall refund to those customers that have previously contributed to the cost of the extension that amount necessary to reduce their contribution to the currently calculated amount for each customer connected to the extension. All customers directly connected to the extension for a five (5) year period after it is placed in service shall contribute equally to the cost of construction of the extension. In addition, each customer shall pay the approved tap-on fee applicable at the time of his application for the meter connection. The tap-on fee shall not be considered part of the refundable cost of the extension and may be changed during the refund period. After five (5) year refund period expires, any additional customer shall be connected to the extension for the amount of the approved tap-on fee only. After the five (5) year refund period expires, the utility shall be required to make refunds for an additional five (5) year period in accordance with subparagraph 1 of this paragraph.

The Oldham County Water District, a water district organized pursuant to Chapter 74 of the Kentucky Revised Statutes, will make the following charges for multi-party meters and connections to all multi-party meters installed within the District.

When Oldham County Water District approves installation of a multi-party meter for service to more than one customer, charges for all customers using that multi-party meter will be computed in the following manner. The total number of customers using the multi-party meter will be divided into the charges incurred on the multi-party meter, and in addition thereto each customer will be charged the initial base rate for their particular type of use. Charges on the multi-party meter will be based on the regular tariff schedule filed with the Public Service Commission, and on file in the office of the Oldham County Water District at Buckner, Kentucky.

INTERPRRETING CUSTOMER DEPOSIT TO BE PAID

The Oldham County Water District, a water district organized pursuant to Kentucky Revised Statutes, will make the following change on deposit from customer, and the amount of deposit to be paid to water district by the customer.

Oldham County Water District will determine the amount of meter deposit required, based on 2/12 of annual usage of similar customer of the water district.

Interest on customer deposit will be paid annually either by refund or credit to the customer's bill, except that no refund or credit will be made if the customer's bill is delinquent on the anniversary date of the deposit. Interest amount will be an appropriate amount.

INTERPRETING INTEREST TO BE PAID AND CUSTOMER DEPOSIT RETURN

The Oldham County Water District, a water district organized pursuant to Kentucky Revised Statutes, will make the following changes on interest and return of deposit to customer.

A customer will be refunded their deposit plus appropriate interest after (18) months of having no cut off violation during this time period.

Interest on customer deposit will be paid annually either by refund or credit on bill.

Any customer receiving credit to their account after (18) months with no cut off and then a cut off has be implemented the customer must then be required to reinstate meter deposit before water service will be turned back on.

Credit for returned meter deposit will be shown on customers water bill.

FIRE DEPARTMENTS

Any city, county, urban-county, charter county, fire protection district, or volunteer fire protection district ("User") may withdraw water from the utility's water distribution system for the purpose of fighting fires or training firefighters at no charge on the condition that it maintains estimates of the amount of water used for fire protection and training during the calendar month and reports the amount of this water usage to the utility no later than the 15th day of the following calendar month.

Any city, county, urban-county, charter county, fire protection district, or volunteer fire protection district that withdraws water from the utility's water distribution system for fire protection or training purposes and fails to submit the required report on water usage in a timely manner shall be assessed the cost of this water.

A non-reporting user's usage shall be presumed to be 0.3 percent of the utility's total water sales for the calendar month. A non-reporting user may present evidence of its actual usage to rebut the presumed usage. The utility shall consider this evidence and may adjust the presumed usage amount accordingly.

The non-reporting user shall be billed for this usage at the lowest usage block rate regardless of customer classification that the utility charges.

A non-reporting user shall also be assessed a penalty of \$ 1.00 for each failure to submit a report in a timely manner.

BY-LAWS, RULES AND REGULATIONS

The Commissioners of the Oldham County Water District of Oldham County, Kentucky, at a meeting August 1, 1989, adopted the following By-Laws and Regulations.

ARTICLE 1. NAME: The name of this District is the Oldham County Water District. The principal office of this District shall be located at Buckner, Kentucky, but the District may maintain offices and places of business at such other places within the State as the Commissioners may designate.

ARTICLE 2. SEAL: The seal of the District shall have inscribed thereon the name of the District and such other inscription as the Commissioners may designate and adopt. The Secretary of the District shall have custody of the seal.

ARTICLE 3. MEMBERSHIP: The customers are the members off this District. The duties of the members are set out hereinafter. A customer must enter into a written users agreement for water service at the office of the District. Said agreement, including service received thereunder, is not assignable by the customer, unless prior written approval is obtained from the District.

ARTICLE 4. COMMISSIONERS: The Commission is a body corporate as approved by KRS 74.070 and is created and its powers and duties are coincident with applicable Kentucky Statutes. The business and affairs of the ~~the District~~ ^{PUBLIC SERVICE COMMISSION} shall be conducted by Commissioners who have been appointed ~~or reappointed~~ ^{or reappointed} pursuant to the statute. The Commissioners of the District shall be selected annually by the County Judge of Oldham County, Kentucky, during the first month of the fiscal year, or at the annual meeting as fixed by the Secretary. such meetings and special meetings by giving the other Commissioners reasonable notice by telephone. There are five (5) Commissioners, and three (3) Commissioners constitute a quorum.

ARTICLE 6. OFFICERS: Officers shall be elected annually at the first meeting of the fiscal year, but in the event the election is not to be held, officers shall continue to hold office until an election is requested by one (1) of the Commissioners.

ARTICLE 7. SALARIES: The Commissioners shall receive an annual salary to be fixed by the County Court and paid out of the Water District funds as provided by KRS 74 and further as provided by law.

ARTICLE 8. BONDS: The District shall pay for the purchase of the fidelity bond of each Commissioner required by the Court and the position fidelity bond of the Treasurer.

ARTICLE 9. VACANCIES: Vacancies of the Commission shall be filled by the County Court.

ARTICLE 10. TREASURER'S DUTY: The Treasurer of the Commission shall pay out of the funds of the Commission only upon presentation of warrants signed by the Chairman and countersigned by the Secretary of the Commission. As compensation for his services the Treasurer shall receive an amount fixed by the Commission, not to exceed Two Hundred (\$200.00) Dollars. He shall execute bond to the Commission in an amount fixed by the Commission.

ARTICLE 11. POWERS: The Commission may ~~acquire~~ ^{OF KENTUCKY} and install pipe and water laterals, and operate a water system. The Commission shall be a body corporate for all purposes, and may make contracts for the water district with municipalities and persons for a water supply, and for the sale of water and for all other purposes connected with its ~~business~~ ^{business}. It may ~~prosecute and defend suits, hire necessary employees, including Commissioners for duties to which their salary limitation herein~~ ⁰¹¹

shall not apply, and to do all acts necessary to carry on the work. It may establish and revise a fiscal year. The Commission shall have all powers provided by Kentucky Statutes, including KRS 74 and KRS 106.

ARTICLE 12. RATES: The Commission may request the Public Service Commission to adjust water rates, and make reasonable regulations for the disposition and consumption of water.

ARTICLE 13. DISPOSITION OF ASSETS: In the event the District terminates business by reason of liquidation or sale of its assets, and in the event there is a sum of money remaining after the District has sold its property and paid its debts of every kind, including all bonded indebtedness, then the District shall seek court approval of a distribution of the money based on the following plan:

(a) One-half (1/2) of the said money shall be distributed to the original subscribers, their heirs, devisees and assigns in direct ratio to the connection fees paid by them prior to construction of the original line;

(b) One-half (1/2) of the said money shall be distributed to each customer, his heirs, devisees and assigns, who has at any time purchased water from the District, in direct ratio to the total water bill the customer paid during the entire operation of the system.

The District does not in any way represent that this means of disposing of the assets of the District in the event of liquidation of sale will be approved by the Court.

ARTICLE 14. MISCELLANEOUS: ~~The Commission may~~ acquire a water line or system operating in the District as provided by KRS 74.100, or other facilities as may be necessary in the opinion of the District.

ARTICLE 16. All buildings, tanks, equipment are to be inspected at least once per year, and a file kept noting the dates of inspection(s), condition of building, tank or equipment; and corrective procedures taken, if needed.

ARTICLE 17. The Commissioners will not, without the consent of the bond holders and the Public Service Commission, take any action with respect to diminishing the territorial limits of the District and will notify the Public Service Commission of any proposal or petition to diminish the territorial limits of the District as soon as the Commission has acquired knowledge thereof.

ARTICLE 18. The Commission may finance the acquisition and the construction of authorized works of improvement by the issuance of (1) special assessment bonds; (2) revenue bonds, or (3) a combination special assessment and revenue bonds, payable primarily from water revenue supplemented, when necessary, by special assessments. If the combination special assessment and revenue bond is used, the special assessment will not be levied, nor will the lien thereof be attached until such time as it is necessary to make up any deficit in the water revenue to meet annual obligations.

ARTICLE 19. The Commission may issue refunding bonds as provided by KRS 74.320 and 74.330 and KRS 106, or as may be provided by other laws of Kentucky and the United States.

ARTICLE 20. The Commission shall keep a ~~record~~ ^{of account} of the time spent by all employees employed on an hourly ~~basis~~ ^{basis} and each item of expense incurred in connection with the District.

ARTICLE 21. The fees of officers for services rendered in such capacity shall be the same as ~~fees~~ ^{fees now} allowed by law for similar services in other cases. Such fees shall be taxed as a part of the costs and paid on order of the Court. Fees or

compensation for any service and otherwise provided for shall be fixed and paid by the Commission.

ARTICLE 22. The Commissioners shall secure personnel to repair and maintain District property including mains, lines, meters, storage tanks, etc. when necessary, shall secure personnel to read meters and shall secure personnel to bill customers. The Commissioners may retain an attorney to represent the District. The District may enter into contracts for services, labor, material and construction as provided by law.

ARTICLE 23. The Commission may make all provisions concerning contracts for sale of water, connection charges, and other disposition of District services and assets, including the plan of collecting proceeds thereof. The system manager may at his discretion discontinue delivery of water to any delinquent customer. The District shall install, maintain and operate a main distribution pipe line or lines from the source of water supply and service lines from the main distribution pipe line or lines to the property line of each customer of the District, if the District Commission determines it is feasible to serve such customer, at which points, designated as delivery points, meters to be purchased, installed, owned and maintained by the District shall be placed. The cost of service line or lines from the main distribution pipe line or lines of the District to the property line of each customer shall be paid by the District or the customer, or both, in a manner to be determined by the Commission at the time of installation, depending upon the length of the service line. The District shall purchase and install a cut-off valve in each service line from its main distribution line or lines, such cut-off valve to be owned and maintained by the District and to be installed on some portion of the service line owned by the District. The District shall have the sole and exclusive right to the use and operation of such cut-off valve.

sufficient capacity to permit the delivery of water through a service line at that point without interfering with the delivery of water through a prior service line. If the District's water system shall be inadequate to permit the delivery of water through a service installed at such point without interfering with the delivery of water through a prior service line, by the Commission. Each customer will be required to install and own the service line from the meter to the place of use on his premises and to maintain such portion of the service line, all subject to applicable rules and regulations of the Utility Regulatory Commission.

Each customer shall be entitled to purchase from the District pursuant to such agreements as may from time to time be provided and required by the Commission such water as the customer may desire, subject however, to the provisions of these By-Laws and to such rules and regulations as may be prescribed by the Commission, provided, however, that should a customer sell or dispose of a portion of his property or subdivide the same he or the new owner of each such new tract may not demand water and taps without paying connection fees for each such tract to be served.

In the event the total water supply shall be insufficient to meet all the needs of the members or in the event there is a shortage of water, the Commission may prorate the water available among the various members on such basis as is deemed equitable by the Commission, and may also prescribe a schedule of hours covering use of water and require adherence thereto or prohibit the use of water for specified purposes.

ARTICLE 24. The Commission is authorized to secure ^{PUBLIC SERVICE COMMISSION OF KENTUCKY} insurance on storage tanks, if any, and such other properties as the District owns, against fire, windstorms and other calamity and liability insurance, in such amounts and with such companies as other privately-owned water systems ordinarily carry.

ARTICLE 25. The District shall own ^{PUBLIC SERVICE COMMISSION OF KENTUCKY} all lines and meters held by or for it, in the absence of a written agreement to the contrary.

ARTICLE 26. The Commission shall secure engineering services for an annual engineering inspection and report dealing with operation and maintenance practice if the Commission desires or if so required by any bond holder or the Federal Government as insurer of the bonds.

ARTICLE 27. The Commission may contract with any person or entity for the sale of water and if such person or entity is meter within the District boundaries, he or it is a member of the District for such time as he or it pays the District bills pertaining to such metered connection.

ARTICLE 28. All applicable Kentucky Statutes which now or may hereafter exist are incorporated herein and made a part of these By-Laws and the Commissioners may use any powers therein contained in addition to those herein set out. Any provision herein in violation of Kentucky Statute which is now or may hereafter be in effect is null and void, the remainder of these By-Laws to continue in full force and effect.

ARTICLE 29. No later than sixty (60) days after the close of each fiscal year copies of an annual audit report certified by the preparing accountant shall be promptly mailed to the Public Service Commission and to any bond holder that may have requested same in writing.

The following rules and regulations are hereby adopted subject to change by the Commission at any time. These rules and regulations are intended to supplement the bond resolution, the rate resolution, and the By-Laws:

- A. All taps and connections to the mains of the District shall be made by and/or under the direction and supervision of District personnel.
- B. Water service may be discontinued by the District for any violation of any rule, regulation, or condition of service and especially for any of the following reasons.

- E. 1. Bills for water service are due and payable at the office of the District, or to any designated agent, on the date of issue. The past due date shall be the tenth day after the date of issue. Bills will be dated and issued on the same day of each month. (T)
- 2. All bills not paid on or before the past due date shall be deemed delinquent. The District may serve a customer a written final notice of said delinquency. If the delinquent bill is not paid within ten (10) days after date of such final notice, the water supply to the customer may be discontinued, after notice as required by law. (T)
- F. Where the water supply to the customer has been discontinued for non-payment of a delinquent bill, a charge of Fifty (\$50.00) Dollars will be made for reconnection of water service, but the reconnection will not be made until after all delinquent bills and other charges, if any owed by the customer to the District, have been paid. If the meter is removed, the charge will be Fifty (\$50.00) Dollars for reconnection. (T)
- G. The District reserves the right to request a nominal sum be placed on deposit with the District for the purpose of establishing or maintaining any customer's credit, subject to rules of the Public Service Commission. However, in no event shall the required deposit be in excess of two-twelfths (2/12) of the estimated-annual bill of such customer pursuant to the Public Service Commission's regulations. (T)
- H. All meters shall be installed, renewed, and maintained at the expense of the District and the District reserves the right to determine the size and type of meter used. (T)

- I. Upon written request of any customer, the meter serving said customer shall be tested by the District. Whenever a meter is found to be more than two percent (2%) fast, additional tests shall be made at once to determine the average error of the meter. Said tests shall be made in accordance with the Utility Regulatory Commission regulations applicable to the type of meter involved. The burden of maintaining measuring equipment so that it will register accurately is upon the utility; therefore, if meters are found upon test to register fast and if time for periodic test has overrun to the extent that one-half (1/2) of the time elapsed since the last previous test exceeds twelve (12) months, the refund shall be for twelve (12) months as specified by 807 KAR 5:006E, Sec. 9(2) and in addition thereto, a like refund for those months exceeding the periodic test period; provided, however, that the commission may relieve the utility from this requirement in any particular case in which it is shown that the failure to make the periodic test was due to causes beyond the utility's control.
- J. When meter has ceased to register, or meter reading could not be obtained, the quantity of water consumed will be based upon an average of the prior three (3) months consumption and the conditions of water service prevailing during the period for which the meter failed to register.
- K. The District shall make all reasonable efforts to eliminate interruption of service and ~~public service commission~~ interruptions occur will endeavor to reestablish service with the shortest possible delay. When the service is interrupted all consumers affected by such interruption will be notified in advance whenever it is possible to do so.
- L. The District shall in no event be held ~~personally~~ responsible, for any claim made against it by reason of the breaking of any mains or service pipes or by reason of any other ~~interruption of the supply of water caused by the failure~~ ~~of any other~~ ~~public service commission manager~~

of machinery or stoppage for necessary repairs. No person shall be entitled to damages nor for any portion of a payment refused for any interruption of service which in the opinion of the District may be deemed necessary.

- M. Customers having boilers and/or pressure vessels receiving a supply of water from the District must have a check valve on the water supply line and a vacuum valve on the steam line to prevent collapse in case the water supply from the District is discontinued or interrupted for any reason, with or without notice. All customers shall have a check valve on the customer's side of the District meter, to prevent back flow into District System.
- N. The premises receiving a supply of water and all service lines, meters and fixtures, including any fixtures within said premises, shall at all reasonable hours be subject to inspection by the District.
- O. Piping on the premises of a customer must be so installed that connections are conveniently located with respect to the District lines and mains. The customer shall provide a place for metering which is unobstructed and accessible at all times.
- P. The customer's service line shall be installed and maintained by the customer at his own expense in a safe and efficient manner and in accordance with the rules and regulations and with the regulations of the Department of Health.
- Q. If any loss or damage to the property of the District or any accident or injury to persons or property is caused by or results from the negligence or wrongful action of the customer, member of his household, his agent or employee, the cost of the necessary repairs or replacements shall be paid by the customer.

District and any liability otherwise resulting shall be that of the customer.

- R. Water furnished by the District may be used for domestic consumption by the customer, member of his household, and employees only. The customer shall not sell or give away the water to any other person. District does not provide fire protection to any customer, any fire protection facility tank, pump or storage unit shall be installed only with prior written consent of the District.
- S. All customers shall grant or convey, or shall be caused to be granted or conveyed, to the District a perpetual easement and right-of-way across any property owned or controlled by the customer wherever said easement or right-of-way is necessary for the District water facilities and lines so as to be able to furnish service to the customer.
- T. Complaints may be made to the operator of the system whose decision may be appealed to the Board of Commissioners of the District within ten (10) days; otherwise, the operator's decision will be final.
- U. The water bills shall be paid at Buckner, Kentucky, office of the Oldham County Water District.







TARIFF SCHEDULE

INTERPRETING LEAK ADJUSTMENTS FOR CUSTOMERS

The Oldham County Water District, a water district organized pursuant to Chapter 74 of the Revised Statutes, will make the following changes on leak adjustments for customers.

There will be (1) adjustment per calendar year. In order to qualify for the adjustment, the customer's usage must be at least (5) times their average usage. The customer's bill will be based on two (2) components. The first step will be to calculate the customer's average monthly usage over a twelve-month period. That usage will be billed at the district's regular rates. The second step will be to deduct the customer's average monthly usage (as calculated above) from the total amount of water that passed through the meter. The usage above the average will be charged at the district's wholesale water rate found in the rates and charges portion of this tariff.

**CONDITIONS FOR RECEIVING WATER
SERVICE IN THE WELLHEAD PROTECTION AREA**

Section 1. APPLICABILITY. The following rules and regulations shall apply to all persons who apply for water service to property located within the Wellhead Protection Area of the Oldham County Water District.

Section 2. DEFINITIONS. Unless the context requires otherwise, certain terms used in these rules and regulations are defined as follows:

- (a) The "District" shall mean the Oldham County Water District;
- (b) "WHPA" shall mean those areas designated, as required by law, by the District as Wellhead Protection Areas One, Two and Three in and near Westport, Kentucky as depicted on the map attached hereto as Appendix A and approved by the Kentucky Division of Water;
- (c) The "Plan" shall mean the District's current Wellhead Protection Plan for the WHPA, attached hereto as Appendix B, and approved by the Kentucky Division of Water as required by law;
- (d) "Customer" shall mean any person or entity who owns property within the WHPA and applies for water service from the District;

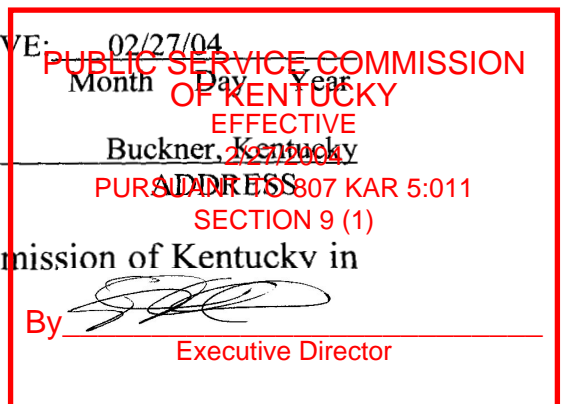

- (e) "Existing Customer" shall mean any person or entity who owns property within the WHPA and who is currently receiving water service from the District at a service location within the WHPA. A person can only be an Existing Customer with respect to a service location or locations within the WHPA currently served by a water meter or meters. If an Existing Customer requests water service to be installed at a different service location within the WHPA, then the person shall be deemed to be a "Customer" and not an "Existing Customer" with respect to the new service location;
- (f) "Advanced Septic System" means a septic system, approved by the District, which is designed to substantially reduce the risk of nitrates leaching into the WHPA; and
- (g) "Conventional Septic System" means a septic system that complies with the usual standards for septic systems installed and operated in Oldham County, Kentucky, and is not designed to substantially reduce the risk of nitrates leaching into the WHPA.


Section 3. PURPOSE. These rules and regulations are intended to protect the public water supply under the Plan by preventing pollution of the underground wells within the WHPA that can result from contaminants, like nitrates, leaching into the groundwater from Conventional Septic Systems.

Section 4. CONDITIONS FOR RECEIVING SERVICE. A

Customer must satisfy the following terms and conditions to receive water service to property located within the WHPA:

- (a) The Customer shall agree to install and maintain an Advanced Septic System, approved by the District, which will substantially reduce the level of nitrates leaching into the groundwater in the WHPA. As a condition precedent to the District's determination of whether any septic system is an Advanced Septic System, the District shall have received from the Customer (i) a written request that the District decide whether the proposed septic system is an Advanced Septic System and (ii) documents, data or information that demonstrates to the District that the proposed system, when installed and operated on the property, will substantially reduce the risk of nitrates leaching into the WHPA;
- (b) The minimum size of the Customer's property receiving water service shall be approximately two (2) acres; or, alternatively, if the Customer's property is part of a subdivision development plat approved by the Oldham County Planning and Zoning Commission, the overall density of the development shall be a minimum of approximately two (2) acres per single family;
- (c) The Customer shall agree to enter into such written declarations, covenants or contracts as are necessary to ensure that these terms and conditions run with the land, are binding upon all parties acquiring an interest in the Customer's property and are automatically imposed upon each successive owner of any portion of the Customer's property; and

- (d) The Customer shall agree that representatives of the District will have the right of access, within its discretion and upon reasonable notice and terms, to inspect the Advanced Septic System on the Customer's property to observe whether it is operating properly. The Customer shall be responsible for maintaining the Advanced Septic System to ensure that it operates properly.

Section 5. EXCEPTIONS. Some or all of the conditions contained in Section 4 for receiving water service do not apply in the following situations:

- (a) None of the conditions apply if a Customer's or an Existing Customer's property is served and continues to be served by a municipal sewer system or a properly functioning package treatment system approved by the Kentucky Division of Water;
- (b) None of the conditions apply to an Existing Customer, regardless of the size of his property, if the property is served and continues to be served by a properly functioning Conventional Septic System; and
- (c) If a property owner's lot is less than two (2) acres and the property owner is not an Existing Customer, then the property owner is exempt from the minimum lot size requirements of Section 4(b) if, and only if, the lot was created by a deed duly executed and recorded on or before April 23, 2003. The property owner, however, must comply with all other provisions of Section 4.

Section 6. DENIAL OR TERMINATION OF SERVICE. Any failure by a Customer or an Existing Customer to meet or comply with these terms and conditions will result in the denial or termination of water service.

Section 7. REBATE. The District acknowledges that (i) the installation of Advanced Septic Systems in the WHPA benefits all persons who receive water from the District, both within and outside the WHPA, by protecting the public water supply and (ii) Advanced Septic Systems are more costly to install than Conventional Septic Systems. Consequently, the District will pay to a Customer or an Existing Customer a one-time payment which represents the difference between the cost of an Advanced Septic System and a Conventional Septic System, but no more than \$4,000 for each Advanced Septic System initially installed within the WHPA by a Customer or an Existing Customer. The payment shall be made at such time as a Customer or an Existing Customer demonstrates, by evidence satisfactory to the District, (i) that an approved Advanced Septic System has been installed and is operating properly on the Customer's or Existing Customer's property located within the WHPA and (ii) the amount of the additional expense incurred by the Customer or Existing Customer in installing an Advanced Septic System instead of a Conventional Septic System.
