SECTION V

CHANGE IN OWNERSHIP, TENANCY OR SERVICE

A new application must be made and approved by the district on any change in ownership of property, or in tenancy, or in the service, as described in the application, and the district shall have the right to discontinue the water supply until such new application is made and approved.

SECTION VI

DEPOSITS

Any applicant may be required to deposit with the district a sum set by the district which shall reasonably approximate the estimated sum to become due from the applicant for two months use of water, based upon the applicant's demands and probable consumption of water, but not less than \$11 in any case. The unused portion of the deposit will be refunded to the applicant after applying such portions as may be necessary to satisfy the applicant's final bill.

RULES & REGULATIONS

A consumer whose service has been discontinued at one residence or place of business will not have the right to require service to be renewed at another residence or place of business until all demands of the district for water furnished have been paid, and its rules and regulations complied with.

(a) When application is made by a person who is not the owner of the premises to be supplied, the district may require a deposit to be made as provided in Section VI.

(b) Where water has been turned off for nonpayment of bill, or for any other valid reason, it shall not be turned on again until the consumer shall have paid the re-connection fee as fixed by these rules and regulations. The same charge shall be made for turning off water at the request of the consumer due to repairs on his premises or to reported vacation or disuse.

SECTION XX

PAYMENT OF BILLS

(a) Water bills shall become delinquent on the date indicated on the bill which is ten days after the billing date.

(b) A ten per cent penalty will be added when the water bill becomes delinquent. The delinquent balance and penalty will be shown on the next bill, in addition to the current bill. Should the second bill become delinquent, a ten day cut off notice will be issued.

(c) In the event that the water service is discontinued for nonpayment of bills or failure to comply with these rules and regulations, a sum of \$2 will be added to the bill and the consumer will be required to pay the full amount due plus a \$10 reconnection fee before the water service will be restored to said property. The consumer shall be required to again make a cash deposit the same as a new consumer.
