# **RULES AND REGULATIONS**

SECTION 1

#### BY COMMISSION

These rules and regulations are made by the BOONE COUNTY WATER DISTRICT and approved by the PUBLIC SERVICE COMMISSION of the COMMONWEALTH OF KENTUCKY, and no official or employee of the BOONE COUNTY WATER DISTRICT has any power or authority to alter or change the same. No agent or employee of the DISTRICT shall have authority to bind it by any promise, agreement, or representation in violation of these rules and regulations.

#### **SECTION 2**

#### SERVICE INSTALLATIONS

(A) Any property owner, or his duly authorized agent, desiring water service shall apply at the District office. The owner shall, in signing the application, agree to be bound by all of the provisions of these rules and regulations, including any amendment thereto. No service branch shall be installed to serve any property which does not abut the street or road along which the water main is located without specific approval of the DISTRICT. Every building wherein water is used shall have a separate service branch and meter provided, however, that the DISTRICT may waive this requirement for good cause shown. The DISTRICT reserves the right to specify the size service branch for each installation. When application for a service branch installation is made, a tapping fee shall be paid according to the following schedule:

#### RULES & REGULATIONS

- (b) To replace or renew an existing service branch the tapping fee shall be actual cost plus twenty-five per cent, but shall not exceed the fee for a new service.
- (c) Upon request from a consumer for an enlargement of a service, the service shall be considered as new and the price of a new service installation will be applicable for a l" service, or larger.
  - (d) After the tapping fee has been paid, the district shall tap the main and install the service connection branch from the main to a location at or near the property line or a point to be determined by the district and a meter, meter box and service cut off will be placed at that point.

#### SECTION III

#### APPLICATION FOR SERVICE

On the application of the owner, or any authorized agent, or tenant of the owner, water will be furnished, through connections already made, or applied for by the owner, and on compliance by the applicant with the rates, rules and regulations of the district, and after the approval of the application by the district indorsed thereon.

The application shall state the name of the owner of the premises, the character and extent of the service desired, a description of the premises, including the name of the street, and the house number, if any, the number and kind of fixtures through which water will be supplied, and such other information as may reasonably be required by the district to enable it to give the desired service.

# SECTION V

CHANGE IN OWNERSHIP, TENANCY OR SERVICE

A NEW APPLICATION MUST BE MADE AND APPROVED BY THE DISTRICT IN ANY CHANGE IN OWNERSHIP OF PROPERTY, OR IN TENANCY, OR IN THE SERVICE, AS DESCRIBED IN THE APPLICATION, AND THE DISTRICT SHALL HAVE THE RIGHT TO DISCONTINUE THE WATER SUPPLY UNTIL SUCH NEW APPLICATION IS MADE AND APPROVED.

SECTION VI

DEPOSITS

EQUAL DEPOSITS

THE DISTRICT REQUIRES A CASH DEPOSIT OF 2/12 OF THE AVERAGE ANNUAL RESIDENTIAL BILL FOR ALL CUSTOMERS TO SECURE PAYMENT OF BILLS. THE AMOUNT OF THE CASH DEPOSIT WILL BE SET ON THE FIRST DAY OF FEBRUARY, BASED ON THE PREVIOUS YEAR EXPERIENCE.

DEPOSITS, Continued
SERVICE MAY BE REFUSED OR DISCONTINUED FOR FAILURE TO PAY THE REQUESTED DEPOSIT. INTEREST, AS PRESCRIBED BY KRS 74.050 WILL BE PAID ANNUALLY EITHER BY REFUND OR CREDIT TO THE CUSTOMER'S BILL, EXCEPT THAT NO REFUND OR CREDIT WILL BE MADE IF THE CUSTOMER'S BILL IS DELINQUENT ON THE ANNIVERSARY DATE OF THE DEPOSIT.
THE DEPOSIT MAY BE WAIVED UPON A CUSTOMER'S SHOWING OF SATISFACTORY PAYMENT HISTORY. REQUIRED DEPOSITS WILL BE RETURNED AFTER THREE (3) YEARS IF THE CUSTOMER HAS ESTABLISHED A SATISFACTORY PAYMENT RECORD FOR THAT PERIOD. IF A DEPOSIT HAS BEEN WAIVED OR RETURNED AND THE CUSTOMER FAILS TO MAINTAIN A SATISFACTORY PAYMENT RECORD, A DEPOSIT MAY THEN BE REQUIRED. THE DISTRICT MAY REQUIRE A DEPOSIT IN ADDITION TO THE INITIAL DEPOSIT IF THERE IS A SUBSTANTIAL CHANGE IN USAGE. UPON TERMINATION OF SERVICE, THE DEPOSIT, ANY PRINCIPAL AMOUNTS, AND ANY INTEREST EARNED AND OWING WILL BE CREDITED TO THE FINAL BILL WITH ANY REMAINDER REFUNDED TO THE CUSTOMER.

#### SECTION VII

#### CONNECTIONS

The district will determine or approve all meter locations, and will furnish and maintain at its own cost all necessary fittings, pipes and appliances, including all meters and meter boxes, to deliver water to the consumer's pipeline, at a point near the property line. All such fittings, pipes, appliances, meters and meter boxes shall remain the property of the district and shall at all times be accessible to it, and under its control.

The service line from the point of connection to the pipe provided by the district which extends from the consumer's side of the meter box to the consumer's premises shall be laid and maintained by the applicant at his own cost. The line shall be of ample size, of standard weight and quality, and all cut-offs, valves, fixtures, and appliances furnished by the consumer shall be maintained in good order and condition. All such service lines shall be subject to inspection and approval by the district and the State Plumbing Inspector before the water supply will be turned on for use.

It shall not be permitted for any customer of the district to have piping within a house cross connected to any other source of water supply.

No connection into more than one building shall be made from any one tap unless the district has given its approval in writing.

#### SECTION VIII

#### **LEAKS**

All leaks in any pipe or fixture on the premises of the consumer shall be immediately repaired. On failure to repair any such leak, the service may be discontinued until repairs are made.

#### SECTION IX

#### INSPECTION

All pipes, meters and fixtures shall, at all reasonable hours, be subject to inspection by the district, or its duly authorized agents.

#### SECTION X

#### DAMAGES

The district shall in no event be responsible for maintaining any service line owned by the consumer, nor for damages done by water escaping therefrom, nor for defects in lines, or fixtures, on the property of the consumer. The consumer shall at all times comply with all regulations of the district, relating to the service lines, and shall make all changes in his line required on account of change in grade, or otherwise.

All injury to service pipes or street mains caused by careless or negligent work, or improper filling of excavations, shall be chargeable to the persons causing such injury, and the expense of repairing the same shall be recovered from such person.

#### SECTION XI

# CONSUMERS

The word "consumer" as used in these rules and regulations shall be construed to mean each separate family, business, firm, corporation or individual taking water through a single service pipe for a single building or business for domestic, agriculture or business purpoes; provided, however, that:

- (a) The owner of a single building used as a multiple family dwelling or apartment house, and the owner of a mobile home park, occupied by one or more families, may connect such building, multiple family dwelling, apartment house or mobile home park, if not already connected, with the mains of the district, and be served by a single service line for which a minimum charge shall be paid according to the number of dwelling units, apartments, or mobile homes, in which case the application for service shall be made by the owner or his duly authorized agent and the bills for water shall be paid by the owner;
- (b) Each separate store or place of business fronting twenty-five (25) feet or less on the street, if supplied with water connection or if using water from the district's mains, shall be considered a separate building, and shall pay a separate minimum;
- (c) Where two or more families or places of business, or offices in a single building are supplied with water through a single service line each may be considered a separate building and shall pay a separate minimum.

#### RULES & REGULATIONS

(d) When the owner of the building either in person, or by his duly authorized agent fails or refuses to sign an application for service, or fails to pay the bills for water when due, or fails to abide by all the rules and regulations of the district, the service may be discontinued; but no such action involving the shutting off of the water supply of an innocent consumer shall be taken without first affording the tenant of the premises opportunity to make a new application for a supply of water through a separate service line or meter.

#### SECTION XII

#### STOP AND WASTE VALVE

A stop and waste cock or cut-off valve must be placed in the pipeline on the premises of the consumer, to be used in case of break or other necessity, whereby pipes to be repaired can be cut off without the necessity of using the street corporation or meter box cut-off.

#### SECTION XIII

#### **METERS**

All meters shall be furnished by the district and shall remain its property and be accessible to and subject to its control. They shall be conveniently located at a point approved by the district, so as to control the entire supply, and when located on premises of consumer a proper place therefor shall be provided by consumer.

#### RULES & REGULATIONS

- (a) Where water is furnished by a flat rate, the district shall have the right to install, maintain and inspect a meter to determine the quantity supplied, and the consumer shall provide a suitable location therefor. The district shall have the right to continue the use of the meter, and furnish water by meter rate only, and the consumer shall thereafter pay the meter rate schedule. The district also reserves the right to change from flat rate service to metered service at any time.
- (b) The district shall maintain all meters without charge to the consumer with the exception that if a meter should be destroyed or damaged through negligence of the consumer, the cost of replacement or repair shall be charged to the consumer. Failure to pay this charge will result in the discontinuance of the service. The consumer shall notify the district of any injury to or failure of the meter as soon as it comes to his knowledge.
- (c) When water is furnished by meter, the quantity recorded by it shall be conclusive on both the consumer and the district, except when the meter has been found to be registering inaccurately or has ceased to register. In the latter case the quantity may be determined by the average registration of the meter when in order.
- (d) Meters will be removed and tested for accuracy when requested by any consumer providing that the consumer, or a representative of the consumer, accompany said meter to the office to witness the test. However, the cost of such testing shall be paid by the consumer in the event that the accuracy of the meter is within two per cent of a true and correct reading. In the event the meter so tested is found to have an error in registration of two per cent, or more, the cost of testing shall be borne by the district and a new or reconditioned tested meter will be installed at no cost to the consumer, and the bills will be increased or decreased accordingly, not to exceed the previous twelve months.

#### RULES & REGULATIONS

#### SECTION XIV

#### DISCONTINUANCE OF SERVICE

Service under any application, including public fire protection, and any other municipal use, may be discontinued for any of the following reasons:

- (a) For misrepresentation, in the application, as to property or fixtures to be supplied, or the use to be made of the water supply.
- (b) For the use of water for any other property or purpose than that described in the application. Use of running water to prevent freezing, or to cool containers or the contents is particularly prohibited.
- (c) Under flat rate service, for adding to said property or fixtures or for changing the use to be made of the water supply, without notice to and the consent of the district.
- (d) For wilful waste of water through improper or imperfect pipes, fixtures, or otherwise.
- (e) For failure to protect and maintain the connections, service lines, or fixtures in good order.
- (f) For neglecting to make or renew advance payments, or for nonpayment of any account for water supplied, or water service or fire protection, or of any scheduled fee or charge as required by these rules and regulations.
- (g) For molesting any service pipe, meter, curb stop cock, or any other appliance of the district controlling or regulating the water supply.

- (h) In case of vacancy of premises.
- (i) For violation of any of these rules and regulations.

Water will be turned off of any premises, on the written order of the consumer, without in any way affecting the existing application, except in those cases where the consumer has a continuing obligation to pay the monthly minumum bill under the terms of the original application.

#### SECTION XV

#### MANNER OF CUTTING OFF WATER SUPPLY

No water fixture or applicance in connection therewith will be considered cut off until it is discontinued so that it cannot be used again, or is sealed in a manner satisfactory to the district.

#### SECTION XVI

PERSONS AUTHORIZED TO TURN WATER ON OR OFF

No plumber, owner, or other unauthorized person shall turn the water on or off at any corporation stop, curb stop or meter box, or disconnect or remove the meter or enter the meter box without the consent of the district.

#### SECTION XVII

#### IN EVENT OF EMERGENCY

As necessity may arise in case of break, emergency, or for other unavoidable cause, the district shall have the right to temporarily cut off the water supply, on order to make necessary repairs, connections, or alterations; but the district will use all reasonable and practicable measures to notify the consumer of such discontinuance of service. In such a case, the district shall not be liable for any damage or inconvenience suffered by the consumer, or for any claim against it at any time for interruption in service, lessening of the supply, inadequate pressure, a poor quality of water, or for any causes reasonably beyond its control.

#### SECTION XVIII

#### RESERVE FOR EMERGENCY

The district shall have the right to reserve a sufficient supply of water at all times in its reservoirs to provide for fires and other emergencies, or may restrict or regulate the quantity of water used by consumers in case of scarcity, or whenever the public welfare may require it.

# SECTION XIX

#### REMOVAL OF SERVICE

When service has been discontinued, it will be renewed under a proper application, when conditions under which the service was suspended are corrected, and on the payment of all charges provided by these rules and regulations.

# **RULES AND REGULATIONS**

A CUSTOMER WHOSE SERVICE HAS BEEN DISCONTINUED AT ONE RESIDENCE OR PLACE OF BUSINESS WILL NOT HAVE THE RIGHT TO REQUIRE SERVICE TO BE RENEWED AT ANOTHER RESIDENCE OR PLACE OF BUSINESS UNTIL ALL DEMANDS OF THE DISTRICT FOR WATER FURNISHED HAVE BEEN PAID, AND ITS RULES AND REGULATIONS COMPLIED WITH.

- (A) WHEN APPLICATION IS MADE BY A PERSON WHO IS NOT THE OWNER OF THE PREMISES TO BE SUPPLIED. THE DISTRICT MAY REQUIRE A DEPOSIT TO BE MADE AS PROVIDED IN SECTION VI.
- (B) WHERE WATER HAS BEEN TURNED OFF FOR NONPAYMENT OF A BILL, OR FOR ANY OTHER VALID REASON, IT SHALL NOT BE TURNED ON AGAIN UNTIL THE CUSTOMER SHALL HAVE PAID THE RE-CONNECTION FEE AS FIXED BY THESE RULES AND REGULATIONS. A RECONNECT CHARGE SHALL APPLY LIKEWISE FOR SERVICE RECONNECTIONS WHEREIN A CUSTOMER HAS REQUESTED SERVICE TO BE TEMPORARILY DISCONTINUED.

#### SECTION XX PAYMENT OF BILLS

- A. WATER BILLS SHALL BECOME DELINQUENT ON THE DATE INDICATED ON THE BILL WHICH IS MINIMALLY TEN DAYS AFTER THE BILLING DATE.
- B. A TEN PERCENT (10%) PENALTY WILL BE ADDED WHEN THE WATER BILL BECOMES DELINQUENT. THE DELINQUENT BALANCE AND PENALTY WILL BE SHOWN ON THE NEXT BILL. IN ADDITION TO THE CURRENT BILLS. SHOULD THE SECOND BILL BECOME DELINQUENT, A TEN (10) DAY CUT OFF NOTICE WILL BE ISSUED.
- C. IN THE EVENT THE WATER SERVICE IS DISCONTINUED FOR NONPAYMENT OF BILLS OR FAILURE TO COMPLY WITH THESE RULES AND REGULATIONS, A SUM OF TWENTY FIVE DOLLARS (\$25.00) FOR RECONNECTION DURING NORMAL BUSINESS HOURS OR A SUM OF THIRTY SEVEN DOLLARS FIFTY CENTS (\$37.50) FOR RECONNECTION AFTER BUSINESS HOURS WILL BE ADDED TO THE BILL AND THE CUSTOMER WILL BE REQUIRED TO PAY THE FULL AMOUNT DUE BEFORE THE WATER SERVICE WILL BE RESTORED TO THE PROPERTY. THE CUSTOMER SHALL BE REQUIRED TO AGAIN MAKE A CASH DEPOSIT THE SAME AS A NEW CUSTOMER IF ORIGINAL DEPOSIT HAS BEEN RETURNED OR APPLIED TO THE DEFICIENT ACCOUNT.

# SECTION XXI

#### ABATEMENT AND REFUNDS

Abatement or refund will be made of a portion of flat rate charges in the proportion that the period of vacancy of the premises bears to the entire period for which payment is due or has been made, provided that no abatement or refund shall be made for fractions of a month.

# SECTION XXII

#### ADJUSTMENT OF WATER BILLS

- (a) No reduction in water charges or billing shall be made for leakage except after an investigation which shows that the leakage is underground and not subject to detection by ordinary methods, and where the owner and other occupants of the premises are free from negligence in causing or failing to report the leakage, or during periods of emergency where and by reason of shortage of material or manpower immediate repairs are not available.
- (b) The amount allowed as a reduction for leakage shall not reduce the water bill to a sum less than the stated minimum for the size service involved.

#### SECTION XXIII

# USE OF WATER FROM FIRE HYDRANT

No person except an employee of the district, duly authorized, shall take water from any fire hydrant for any purpose except for fire purpose or for use of the fire department in case of fire, and water shall not be taken from a fire hydrant for sprinkling streets, flushing gutters or sewers, or for any purpose except the extinguishment of fires, unless specially permitted in writing by the district for the particular time and occasion.

#### SECTION XXIV

#### FURNISHING OF WATER BY CONSUMER TO OTHERS

No consumer will be allowed to provide water service or resell water to another person, except in cases of emergency, and then only for a limited time, or until such emergency shall have passed, or except when the water is purchased at a designated public loading station.

# SECTION XXV

#### WATER FOR TEMPORARY USE

- (a) Where water is required for temporary use in connection with construction, the party desiring the temporary service shall apply for a permit from the district at the district office. Unmetered water shall be paid for on the basis of metered rates according to the estimated amount used or to be used.
- (b) In the case of a large construction project the district shall require the use of a special meter to register water consumed. The meter in such case shall be furnished by the district without charge, providing that the person obtaining the meter shall be charged for the cost of the meter itself if it is not returned promptly after the discontinuance of its use.
- (c) Any special connections or taps required to make temporary use of water available shall be made by the district and shall be paid for by the party desiring the temporary service. Charges shall be the cost of installation plus twenty-five per cent.

#### SECTION XXVI

# PRIVATE FIRE HYDRANT AND SPRINKLING SYSTEMS

Connections from the water distribution system for private fire protection will be constructed on main not less than 6" size. These connections will be handled on special contract with the district and the person or persons requesting such service installation.

#### SECTION XXVII

#### WATER MAIN EXTENSIONS

- (a) All persons desiring to construct water mains and connect same to the district's system shall, prior to commencement of such construction, submit detailed plans of same to the district for approval. Such plans must be prepared by a civil engineer registered in Kentucky, conform to the requirements and specifications of the State and County Health Departments and the Kentucky Inspection Bureau, and not interfere with the operation and plans for expansion of the district, and shall conform to the location, type and size of mains prescribed by the district.
- (b) The district shall not agree to provide service or to assume maintenance and repairs of water mains constructed by others unless full control and ownership of said mains is conveyed to the district, and the contractor agrees in writing to assume full responsibility for maintenance and repairs to the water main for a period of 12 months from the construction date.

# **RULES AND REGULATIONS**

#### WATER SERVICE FOR FIRE DEPARTMENTS

Any city or county fire protection district, or fire protection district ("User") may withdraw water from the utility's water distribution system for the purpose of fighting fires and/or training firefighters at no charge on the condition that it maintains estimates of the amount of water used for fighting fires and/or training during the calendar month and reports the amount of this water usage to the utility no later than the 15th day of the following calendar month.

Any city or county fire protection district, or fire protection district that withdraws water from the utility's water distribution system for fighting fires and/or training purposes and fails to submit the required report on water usage within 60 days of the report calendar month shall be assessed the cost of the water. A User shall submit a monthly report even if it withdraws no water for fire protection or training purposes.

A non-reporting user's report shall be presumed to be 0.3 percent of the utility's total water sales for the calendar month. A non-reporting User may present evidence of its actual usage to rebut the presumed usage. The utility shall consider this evidence and shall adjust the presumed usage amount accordingly.

The non-reporting user shall be billed for this usage at the lowest usage block rate regardless of customer classification and the utility charges.

A non-reporting user shall also be assessed a penalty of \$10.00 for each failure to submit a report within 60 days of the report calendar month.
