RULES AND REGULATIONS

- 4. Waste or misuse of water due to improper or imperfect service pipes and /or failure to keep in suitable state of repair.
 - 5. Tampering with meter, meter seal, service, or valves or permitting such tampering by others.
 - 6. Connection, cross connection, or permitting the same, of any seperated water supply to premises which receive water from the District.
 - 7. Non-payment of bills.
- C. Any customer desiring to discontinue the water service to his premises for any reason must give three (3) working days notice of discontinuance in writing in person or by telephone at the business office of the District; otherwise, a customer shall remain liable for all water used and service rendered by the District until said notice is received by the District.
- D. Bills and notices relating to the conduct of the business of the District will be mailed to the customer at the address listed on the user's agreement unless a change of address has been filed in writing with the District; and the District shall not otherwise be responsible for delivery of any bill or notice nor will the customer be excused from the payment of any bill or any performance required in said notice.
- E. 1. Bills for water service are due and payable at the office of the District, or to any designated agent, on the date of issue. The past due date shall be the fifteenth day after the date of issue. Bills will be dated and mailed on the first day of each month.
2. All bills not paid on or before the past due date shall be deemed delinquent. The District may serve a customer a written final notice of said delinquency. If delinquent bill is not paid within ten days after date of such final notice, the water supply to the customer may be discontinued without further notice.
3. All delinquent bills will be assessed a 5% penalty in accordance with 807 KAR 5:011, Section 10.
- F. Where the water supply to the customer has been discontinued for non-payment of delinquent bills, a charge of \$35.00 will be made for reconnection of water service but reconnection will not be made until all delinquent bills and other charges, if any, owed by the customer to the District have been paid.
