

**RULES AND REGULATIONS**

The following rules and regulations are subject to change by the Board of Directors at any time subject to approval by the Public Service Commission.

1. Meters shall be read monthly by the consumers on the 10<sup>th</sup> of each month.
2. Bills are payable within 10 days after reading on the 10<sup>th</sup> of each month.
3. All meters will be located on association mains and in the absence of special permission on the property to be served.
4. Complaints may be made to the operator of the system and may be appealed to the Board of Directors.
5. Failure to pay water charges duly imposed results in these penalties:
  - A. Non-payment by 20<sup>th</sup> of month, penalty of 10% of delinquent account
  - B. Non-payment within 30 days from due date, water will be shut off.
  - C. Non-payment within 30 days from due date, association may purchase member's membership certificate and terminate his membership.
  - D. If water is shut off to consumer for delinquency or violation of any of the rules or regulations of the association, a fee of \$10.00 will be charged for reconnection of service.
6. A fee of \$10.00 will be charged on each trip for purpose of collecting a delinquent account.
7. A fee of \$10.00 will be charged on a trip to read a meter when the member has failed to read and pay by the end of the month.
8. Property owners will be responsible for tenant's water bills, unless tenants have paid the required deposit.

9. In occupancy changes, a charge of \$3.00 shall be made for reading a meter and turning off the meter and a charge of \$3.00 shall be made for reading and reconnecting a meter when the property is re-occupied.
