## WATER PURCHASE CONTRACT (Amendment) BETWEEN THE ELECTRIC PLANT BOARD OF THE CITY OF VANCEBURG AND GARRISON, QUINCY, KY-O-HEIGHTS WATER DISTRICT

THIS WATER PURCHASE CONTRACT AMENDMENT, made and entered into by and between the ELECTRIC PLANT BOARD OF THE CITY OF VANCEBURG, ("Seller"), and GARRISON, QUINCY, KY-O-HEIGHTS WATER DISTRICT, ("Purchaser") as of the date set forth below,

## Witnesseth:

That for and in consideration of the mutual benefits of the parties hereto, and for payment by Purchaser to Seller of the purchase price for the quantities of water to be delivered as set forth in sections "A" and "B" below.

Seller and Purchaser agree that the following amendment shall be incorporated into and become a part of the Agreement between the parties dated April 17, 1995.

Amend both sections "A The Seller Agrees:" and "B. The Purchaser Agrees:" the quantity of water that the Electric Plant Board of the City of Vanceburg agrees to sell Garrison, Quincy, KY-O-Heights Water District shall be from 1,000,000 gallons to 3,000,000 gallons per month.

The amendment will cause section "A" paragraph 1 to read as follows:

- A. The Seller Agrees:
  - 1. (Quality and Quantity) To furnish the Purchaser at the point of delivery hereinafter specified, during the term of this contract or any renewal or extension thereof, potable treated water meeting applicable purity standards of the Kentucky Division of Water in such quantity as may be required by the Purchaser not to exceed 3,000,000 gallons per month.

The amendment will also cause section "B" paragraph 1 to read as follows:

- B. The Purchaser Agrees:
  - 1. (Rates and Payment Date) To pay the Seller, not later than the 15<sup>th</sup> day of each month, for water delivered in accordance with the following schedule of rates:
    - a. \$1.68 per 1,000 gallons of water delivered.
    - b. \$0.168 cents per 1,000 gallons for water in excess of 3,000,000 gallons, as a penalty or over usage which penalty amount shall be added to the usual charge for water.

This Water Purchase Contract Amendment shall be effective as of the date of the signature of the last party to sign same.
