RULES AND REGULATIONS

The following Rules and Regulations were adopted by the Board of Directors of the Harrison County Water Association, Inc., at a regularly held meeting on May 17, 2000, which replaces the previous tariffs adopted on December 8, 1982, and changes made on May 8, 1985, January 22, March 21, 1990, and December 16, 1998, and January 17, 1999. These Rules and Regulations were unanimously adopted by the Board of Directors. The changes in Exhibit "A" (pages 29, 30 and 31) and the rate changes contained on pages 14-28 (designated with an "I") were issued by authority of an Order of the Public Service Commission in Case No. 1999-409 and Case No. 2000-139, dated April 27, 2000.

RULES AND REGULATIONS

1. All taps and connections to the mains of the Association shall be made by and/or under the direction and supervision of Association personnel.

All meters will be located near Association mains. Extension of service from the meter shall be at the expense of the customer and by the customer's arrangements, subject to Association approval, and in accordance with the Associations' Rules and Regulations and the regulations of the Department of Health. In addition, the customer PUBLIC SERVICE COMMISSING responsible for maintenance of the service line from the OF KENTUMEY er to the point of use. Extension of service to new customers EFFECTIVE hall be in accordance with the connection fee approved by the Public Service Commission.

- A. Misrepresentation in the application or contract as to the property or fixtures to be supplied or additional use to be made of water.
- B. Failure to report to the Association additions to the property or fixtures to be supplied or additional use to be made of water.
- C. Resale of water.
- D. Waste or misuse of water due to improper or imperfect service pipes and/or failure to keep in suitable state of repair.
- E. Tampering with meter, meter seal, service, or valves or permitting such tampering by others.

Each meter will be read monthly by the Association unless weather 3. conditions prevent such reading in which case the customer will be billed on an estimate based on past usage.

Bills will be dated and mailed the first of each month and shall cover the 30 day period of usage to the 15th day of the previous month. Said bills will state that they are due by the 17th day of the month mailed and they are delinquent and past due if not paid within 10 days of the mailing date. If bills are not paid in accordance with this schedule there will be a five percent (5%) late charge assessed. Written notice shall be given that service will be discontinued when a bill becomes delinquent. Ten days after written notice is given but not less than 30 days after the mailing date of the original bill, service may be discontinued in conformity with applicable KRS and KAR sections, unless the amount of the delinguent bill is paid in full to the Association.

- D. Where the water supply to the customer has been disconnected for non-payment of delinquent bills, violations of the rules and regulations of the Association or at the customer's request, a reconnection charge will be charged to reconnect water service, but the reconnection will not be made until all delinquent bills and other charges, if any, owed by the customer to the Association have been paid, and the customer has complied with all rules and regulations of the Association. Also, a field collection charge will be charged when a trip is made to collect a delinquent bill. This trip may be made only after a written notice has been sent to a customer stating that if the bill is not paid by a certain date, the services will be disconnected. The Association shall not charge a field collection charge more than once in a billing period.
- 4. Any customer desiring to discontinue the water service to his premises for any reason must give notice of discontinuance at the business office of the Association; otherwise, a customer shall remain liable for all water used and service rendered by the Association until said notice is received.
- 5. Where a meter has ceased to register, or meter reading could not be obtained, the quantity of water consumed for billing purposes will be based upon an average of the prior six months consumption and the conditions of water service prevailing during the period in which the meter failed to register.
- 6. The Association shall make all reasonable efforts to eliminate interruption of service and when such interruptions occur will endeavor to reestablish service with the shortest possible delay. When the service is interrupted all customers affected by such interruption will be notified in advance whenever it is possible to do so.

- 7. The Association shall in no event be held responsible for any claim made against it by reason of the breaking of any mains or service pipes or by reason of any other interruption of the supply of water caused by the failure of machinery or stoppage for necessary repairs. No person shall be entitled to damages nor for any portion of a payment refunded for any interruption of service which in the opinion of the Association may be deemed necessary.
- 8. Customers having boilers, water heaters and/or pressure vessels receiving a supply of water from the Association should have a check valve on the water supply line and a vacuum valve on the steam line to prevent collapse in case the water supply from the Association is discontinued or interrupted for any reason, with or without notice.
- 9. The premises receiving a supply of water and all service lines, meters and fixtures, including any fixtures within said premises, shall at all reasonable hours be subject to inspection by the Association after reasonable notice.
- 10. If any loss or damage to the property of the Association or any accident or other injury to persons or property is caused by or results from the negligence or wrongful action of the customer, member of his household, his agent or employees, as determined by PUBLIC SERVICE-COMMISSION f law having jurisdiction over the parties, the cost of the OF KENTNEK¥ssary repairs or replacements shall be paid by the customer to EFFECTINE Association and any liability otherwise resulting shall be that of the customer.

Upon complaint to the Association by a customer either at its office 12. or in writing, the Association shall make a prompt and complete investigation and advise the complaint thereof. It shall keep a record of all such complaints concerning its water service which shall show the name and address of the complainant, the date and nature of the complaint, and the adjustment or disposition thereof. Complaints shall be initially handled by the operating manager of the Association whose decision may be appealed to the Board of Directors of the Association within 10 days by appearing at a scheduled meeting of the Board or by giving written notice of an Otherwise, the operating manager's decision intent to the Board. or of the Board of Directors of the Association may be appealed to the Public Service Commission pursuant to applicable laws of the Commonwealth.

- 15. Deposits will be applied to the final bill of any member who discontinues service and the remaining balance of the deposit, if any, will be refunded. Interest will be credited or refunded on an annual basis.
- 16. Interest on deposits will be paid at the rate earned. Deposits not refunded will be recalculated in accordance with 807 KAR 5:006, Section 7.
- 17. Every deposit and interest earned thereon shall be refunded to the paying member after three years, provided said member has had no delinquencies of the payment of any bill during that period. Where there are delinquencies, refunds shall be made only after three consecutive years without delinquencies.
- 18. All persons desiring to become a new member and to have a meter installed for the first time shall be required to sign Exhibit "C" which is attached hereto, unless such new member is joining the Association as a result of a project funded by the Farmers Home Administration in which case said member shall also be required to sign Exhibit "A" which is the standard Water User's Agreement of the Farmers Home Administration.

Where the line and service is already in existence but where there has not been 18 consecutive months paid on said service, then any member desiring to have connection to said service, shall be required to sign "Exhibit C".

Otherwise, a user requesting service at services where 18 consecutive months have been by GOFRUCECOMMISSION by another user, shall be required to sign "Exhibit BOF KENTUCKY EFFECTIVE

19. Testing: Testing of water meters for the water customers for the Harrison County Water Association shall be conducted in accordance with the specifications set forth in 807 KAR 5:066, Section 15. The Harrison County Water Association shall, from the date hereof, comply with all testing facility and equipment requirements, with all accuracy requirements and with all periodic testing requirements set forth in 807 KAR 5:066, Section 16. If any customer requests that the meter be checked to determine accuracy, the Water Association will comply with such request as soon as it can, however, if the meter checks out accurate within standards set forth in applicable KAR sections, then the customer shall pay the meter test fee included in the non-recurring charge section of this tariff. If the meter is inaccurate, the cost of the check shall be borne by the Water Association.

20. BLOW OFF HYDRANTS AND FIRE HYDRANTS

Most hydrants installed on the distribution lines of this Water Association are for the primary purpose of flushing the lines, or other uses by the Association necessary for proper maintenance of the lines. Thus, they are blow-off hydrants and not fire hydrants while the secondary purpose might be to assist fire protection units in the performance of their duties, the Harrison County Water Association, Inc., is not responsible for, nor does it guarantee, any minimum pressure at these hydrants, other than the minimum pressure required by the Public Service Commission for distribution lines unless there is an emergency from the water supplier in which case the Association shall see that minimum pressure is restored as soon as possible. Any damage to distribution lines, resulting from excessive pumping pressure applied by any fire fighting unit will be the liability of that unit. The only exceptions thereto are the hydrants installed in Berry, Kentucky and These hydrants, while of fire hydrant size, cannot be Ruddles Mills, Kentucky. guaranteed at any pressure level other than the minimum required by the Public Service Commission. Any damages to these distribution lines resulting from excessive pumping pressure applied by a fire fighting unit shall be the liability of that unit.

WATER MAIN INSTALLATION

- 1. All persons desiring to construct water mains and connect to Harrison County Water Association shall prior to the commencement of such construction, submit detailed plans to the Association for approval. The plans must be prepared by a civil engineer registered in Kentucky, conform to the requirements and specification of the State and County Health Departments and the Kentucky Inspection Bureau and not interfere with the operation and plans for expansion of the Association and shall conform to the location, type, and size of mains prescribed by the Association and conform to all other reasonable regulations of the Association.
- 2. Harrison County shall assume full control and ownership of all lines once construction is completed and all state and federal codes are met. The contractor shall agree in writing to assume full responsibility for maintenance and repairs of the water mains for a period of twelve (12) months from the completion of construction date. After the twelve (12) month period the Association will assume maintenance and repairs of the mains.

HARRISON Co. WATER ASSOC. (Name of Utility)

Any city, county, urban-county, charter county, fire protection district, or volunteer fire protection district ("User") may withdraw water from the utility's water distribution system for fighting fires or training firefighters at no charge on the condition that it maintains estimates of the amount of water used for fire protection and training during the calendar month and reports the amount of this water usage to the utility no later than the 15th day of the following calendar month.

Any User that withdraws water from the utility's water distribution system for fire protection or training purposes and fails to submit the required report on water usage in a timely manner shall be assessed the cost of this water. A User shall submit a monthly report even if it withdraws no water for fire protection or training purposes.

A non-reporting User's usage shall be presumed to be 0.3 percent of the utility's total water sales for the calendar month. A non-reporting User may present evidence of its actual usage to rebut the presumed usage. The utility shall consider this evidence and shall adjust the presumed usage amount accordingly.

The non-reporting User shall be billed for this usage at the lowest usage block rate regardless of customer classification that the utility charges.

A non-reporting User shall also be assessed a penalty of $_25.00$ for each failure to submit a report in a timely manner.

This agreement entered into between the HARRISON COUNTY WATER ASSOCIATION, INC., a non-profit corporation, hereinafter called the "Association" and ______ a

member of the Association, hereinafter called the "Member."

WITNESSETH

WHEREAS, the Member desires to purchase water from the Association and to enter into a water users agreement as required by the By-laws of the Association.

NOW THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, it is hereby understood and agreed:

The Association shall furnish, subject to the limitation set out in its By-laws and Rules and Regulations now in force or as hereafter amended, such quantity of water as Member may desire in connection with Member's occupancy of the following described property:

 	······

NOTE: Enter a general description of the property's location. Lafferty Pk. one mile north of Granger Lane.

The member shall install and maintain at his own expenses a service line which shall begin at the water meter and extend to the dwelling or place of use.

The member agrees to comply with and be bound by the Articles, By-laws, Rules and Regulation of the Association, now in force, or as hereinafter duly and legally supplemented, amended or changed. The Member also agrees to pay for water at such rates, time and place as shall be determined by the Association, and agrees to the imposition of such penalties for non-payment as are now set out in the Association's By laws and Rules and Regulations, or which may be hereafter adopted and imposed by the Association.

The Association shall purchase and install a cutoff valve and a water meter in each residential service. The Association shall have exclusive right to use such cutoff valve and water meter. The Association shall have final authority in any question of location

of any service line connection to its distribution system; shall determine the allocation of water to Members in the event of a water shortage; and may shut off water to a Member who allows a connection or extension to be made of his service line for the purpose of giving or selling water to another user. In the event the total water supply shall be insufficient to meet all of the needs of the Members, or in the event there is a shortage of water, the Association may prorate the available water among the various Members on such basis as is deemed equitable by the Board of Directors, and may also prescribe a schedule of hours covering use of water for garden purposes by particular members and require adherence thereto or prohibit the use of water for garden purposes; provided that, if at any time the total water supply shall be insufficient to meet all of the needs of all of the Members, the Association must first satisfy the needs of all Members for domestic purposes before supplying any water for livestock purposes and must satisfy the needs of all Members for both domestic and livestock purposes before supplying any water for garden purposes.

The Member agrees that no other present or future source of water will be connected to any water lines served by the Association's water lines and will disconnect from his present water supply prior to connecting to and switching to the Association's system and shall eliminate their present or future cross-connections in his system. This would not prohibit the Member from maintaining and using a completely separate auxiliary private water system.

The Member shall connect his service lines to the Association's distribution system and shall begin to use water from the system on the date the water is made available to the Member by the Association. Water charges to the Member shall commence on the date service is made available, regardless of whether the Member connects to the system

IN THE EVENT THE APPLICANT FAILS TO CONNECT A SERVICE TO THE MAIN SUPPLY SYSTEM, HE IS NOT EXEMPT FROM PAYING THE PREVAILING MINIMUM MONTHLY CHARGE FOR A PERIOD OF EIGHTEEN (18) MONTHS FROM DATE WATER SERVICE IS MADE AVAILABLE.

Bills are due on receipt and payable by the 17th of each month. Failure to receive bill does not waive payment. A late charge of five percent (5%) on the total bill will be assessed after the 17th of the month.
