The utility will not restore service until the customer agrees to comply with all rules and regulations of the utility and Public Service Commission.
  - 1) For illegal use or theft of service. The utility may terminate service to a customer without advance notice if it has evidence that a customer has obtained unauthorized service by illegal use or theft. This right of termination is separate from and in addition to any other legal remedies that the utility may pursue for illegal use or theft of service.
  - 2) For dangerous conditions. If a dangerous condition relating to the utility's service which could subject any person to imminent harm or result in substantial damage to the property of the utility or others is found to exist on the customer's premises, then service will be terminated immediately. Upon termination the utility will leave notification at the customer's dwelling and, if possible, orally contact the customer to inform him/her of the reasons for the termination. Such notice will be recorded by the utility and will include the corrective action to be taken by the customer or utility before service can be restored.

## WATER USER'S AGREEMENT

## LAKE VILLAGE WATER ASSOCIATION, INC.

This Agreement, between the Lake Village Water Association, Inc., a non-profit corporation (hereinafter Association) organized and existing under and by virtue of the law of the State of Kentucky, and

, a member of the Association (hereinafter called Member).

## WITNESSETH:

WHEREAS, the Member desires to purchase water for domestic, farm, and other purposes, from the Association, and to enter into a Water User's Agreement as required by the By-Laws of the Association.

NOW THEREFORE, in consideration of the mutual covenants, promises and agreements herein contained, it is hereby understood and agreed:

The Association shall furnish, subject to the limitations hereinafter provided for, such quantity of water for domestic, farm and other purposes, as the Member shall desire in connection with his occupancy of the following described property:

The Association shall purchase and install a cut-off valve and water meter, for each service, provided the Association has determined in advance that the Association's water system is of sufficient capacity to permit delivery of water at that point. Such cut-off valve and meter shall be installed at a point selected by the Association on the Member's property. The Association shall have exclusive right to use such cut-off valve and water meter and to turn it on and off.

The Association shall have final jurisdiction in any question of location of any service line connection to its distribution system; shall determine the allocation of water to members in the event of a water shortage; and the Association may shut off the water to a member who allows a connection or extension to be made to Member's service for the purpose of supplying water to another user.

The Member shall install and maintain, at Member's expense, a service line which shall begin at the meter location and extend to the dwelling and other portions of the premises.

The Member shall pay for such water as such rates, time and place as shall be enterprised by the Association, and shall pay a minimum water bill each month whether any water is installed.

JEFF R. DEROUEN

The Member shall, and does hereby, grant to the Association an easement across the language Member for the purpose of installation of a distribution system and meter box and the N ier grant unto the Association a general easement for ingress and egress over the prope of servicing the lines and meters owned by the Association.

**EXECUTIVE DIRECTOR** 

The Member further agrees to pay such deposits as may be required by the Association under the provision of its approved tariff.

The failure of a Member to pay water charges duly imposed, shall result in the automatic imposition of the following penalties:

- **A:** Non-payment of water charge by the due date will result in a penalty of ten percent of the amount of the delinquent account.
- **B:** Non-payment within thirty days from the due date will result in the initiation of service disconnection procedures by the Association under the provisions of its approved tariff.
- **C:** In the event of disconnection for non-payment the Association will require a fee for the reconnection of the service and a minimum of one (1) day to install the meter.
