- Water bills may be paid at the office between the hours of 9 A.M. and 3 P.M. or mailed 6. to the Post Office at P.O. Box 99, Buffalo, Ky. 42716.
- All bills not paid by the 10th of each month will be subject to a 10% penalty. 7.
- If a customer's water service is discontinued for non-payment, there will be a \$10.00 8. charge for reconnection. Reconnections will be made only during normal working hours.
- 9. Meters are property of the District and are not to be tampered with except by an authorized operator.
- there can be no more than one house, apartment, or mobile home connected in such a 10. way as to be served by one meter.
- 11. The Utility may require from any customer or applicant for service a minimum cash deposit or other quaranty to secure payment of bills of an amount not to exceed twotwelfths (2/12) of the estimated annual bill of such customer or applicant, in accordance with the provisions of 807 KAR 5:006, Section 7. The deposit shall draw interest as required by the applicable rules and regulations of the PSC.
