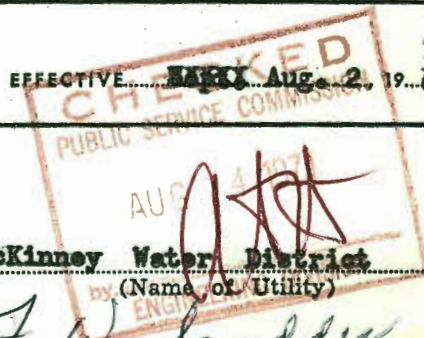

RULES AND REGULATIONS

The following rules and regulations are subject to change by the Water District Commissioners at any time subject to approval by the Public Service Commission.

1. Meters will be read monthly between the 18th and 20th of each month.
2. Bills will be dated and mailed on the first of each month.
Said bill will state that they are to be paid by the 15th. of each month.
3. All meters will be located on district mains and in the absence of special permission on the property to be served.
4. Complaints may be made to the operator of the system and may be appealed to the District Commission.
5. The principal place of business of the District will be Joda Milberns residence McKinney, Kentucky.
6. Water bills may be paid at Joda Milberns residence McKinney, Ky. and the McKinney Variety Store, McKinney, Ky.
