WITNESSETH: whereas the parties to this addendum are the same parties as set out in a certain agreement styled "Water Purchase Contract" of date of October 10, 1967, and whereas the district is now desirous of amending a portion of the terms therein contained, which is agreeable to the City under the conditions specified by this addendum,

NOW THEREFORE, for and in consideration of the Covenants and agreements hereinafter contained the parties hereto agree and do hereby amend those paragraphs and sections of the aforementioned agreement by the including of new paragraphs and/or section and/or changing in whole and/or in parts existing paragraphs and sections thereof, which contract shall from and after the effective date of changes herein, read as if contained in the original agreement:

Page 2. A. The City Agrees

1. (Quality and Quantity) to furnish the District, at the point of delivery heremafter specified, during the term of this contract or any renewal or extension thereof, potable treated water meeting applicable purity standards of the State Board of Health (or other cognizant agency) in such quantity as may be required by the District (not to exceed 4,000.000 gallons per month or 48,000.000 gallons per year).

Page 4. C. It is further mutually agreed between the City and District as follows:

. (Terms of Contract) that this contract shall extend for a term of forty (40) years from date of the initial billing on the extension to be known as Phase II, approximate date August, 1974.

(Water and Testing) As set out in the original agreement with the following add() thereto as the same applies to Phase II; there will be another flat charge of \$200.00 for water for testing.

(Page 6) As set out in the original agreement with the following added thereto: It is further agreed that if, during the existence of this agreement, the City, at its sole discretion, elects to expand its City limits to any area served by the North Nelson Water District in the area which is the subject of this agreement, the City may extend its water facilities and serve customers with-in said area whether or not previously served by the North Nelson Water District.

Provided, however, that should the City of Bardstown extend its water facilities as aforesaid prior to the retirement of the bonded indebtedness of the North Nelson Water District or forty (40) years from the inception of said indebtedness, whichever event occurs sooner, then in that event the North Nelson Water District may continue service to such number of customers in the area then currently being served, but no more than are necessary to maintain reasonable revenue to provide for bond retirement and operating revenue at the then prevailing water rates throughout the District.
