

WATER PURCHASE CONTRACT

This contract made and entered into this 19th day of February, 2018 by and between the **Rattlesnake Ridge Water District**, a water district created and existing under the laws of the Commonwealth of Kentucky, hereinafter referred to "**RATTLESNAKE**" and the **Grayson Utilities Commission**, an entity created by an Ordinance of the City of Grayson, a Kentucky Municipality, authorized by said Ordinance to contract and to operate and maintain the water system of the City of Grayson, hereinafter referred to as "**GRAYSON**";

WHEREAS, **RATTLESNAKE** and **GRAYSON** have operated under certain previous contracts between said entities for the sale and purchase of treated water between the two entities; and

WHEREAS, it is necessary and proper to continue the relationship for same as a result of the necessity to meet pressure requirements and the needs of customers of each entity through the use of water purchased and sold by each entity to the other; and

WHEREAS, the parties are desirous of setting forth in writing their complete agreement concerning the sale and purchase of treated water;

NOW, THEREFORE IN CONSIDERATION of all of the foregoing, and in consideration of the mutual promises and covenants hereinafter contained, the parties do hereby agree as follows:

1. **GRAYSON** agrees to deliver to **RATTLESNAKE** potable treated water meeting applicable purity standards of all appropriate environmental agencies existing within the Commonwealth of Kentucky in such quantities as may be required by **RATTLESNAKE** at the point of delivery known as Stan Branch and at the point of delivery known as Little Fork.
2. **RATTLESNAKE** agrees to supply to **GRAYSON** at the point of delivery known as 5260 South State Highway 7, Grayson, Kentucky, potable treated water in such quantities

deemed necessary by **GRAYSON** for use by the retail customers of **GRAYSON**.

RATTLESNAKE shall pay to **GRAYSON** for all water received at the point of delivery noted hereinabove, and **GRAYSON** shall pay to **RATTLESNAKE** for all water received at the points of delivery noted above, the rate of \$4.30 per 1,000 gallons plus any taxes, or other assessments required by law as may be imposed upon each entity by the appropriate governing authorities which payment is to be received by the 10th day of the following month after the reading of the meter.

3. If either water district rate of the parties hereto increases during the term hereof, then the billing from both would reflect said increase.
4. There shall be a meter associated with the measuring of all water delivered as noted hereinabove for purposes of ascertaining the correct amount of water being supplied.
5. This contract shall be in effect upon the day and date first set forth herein and shall remain in effect for a period of 41 years and shall be automatically renewed at the expiration of said 41 year term unless terminated by either party by giving written notice of intent to terminate sixty (60) days prior to the expiration date of the initial term.
6. Each party agrees to have their metering equipment calibrated at the request of the other upon reasonable frequent request, provided however, that said calibration shall not exceed 2 times per twelve (12) month period. A meter not registering more than two (2%) percent above or below the test results shall be deemed to be accurate. Any meter disclosed to be inaccurate shall be corrected for the period existing immediately following the previous

test to the date of the test determining the inaccurate reading for which appropriate payment shall be made.

7. Each party agrees upon reading of the meters provided for herein to furnish an itemized statement of the amount of water furnished for the preceding month in order to accurately set forth payment to be made.
8. The parties agree that failure to deliver as provided for herein or failure to pay within sixty (60) days following billing shall result in a material breach of the within contract allowing the non-breaching party to take any and all action necessary to enforce the terms of the contract and seek all damages available by law including costs and attorney's fees.
10. This is the entire agreement and neither party is relying upon any other oral or written statement not otherwise provided for herein.
