RULES AND REGULATIONS

Section 13. Deposit.

The District reserves the right to require that a nominal amount be placed on deposit with the District for the purpose of establishing or maintaining any customer's credit. Such amount will be set by the District and approved by the Public Service Commission. Upon payment of said deposit, the District shall issue a certificate of deposit, showing the name of the customer, the location of the initial premises occupied by the customer and the date and amount of the deposit.

Interest will be paid on the deposit at the rate of 6% up until July, 1990. After that date interest will be paid at the current rate which the District is receiving on the Customer Deposit Savings Account. If the deposit is not refunded or credited to the customer's bill prior to the anniversary date interest will be pro-rated. If interest is not credited or paid annually, interest will accrue until credited to the customer's bill or paid to the customer.

Section 14. Meters.

All meters shall be installed, renewed and maintained at the expense of the District. and the District reserves the right to determine the size and type of meter used.

It shall be the policy of the District to test each meter pursuant to Public Service Commission regulation 807 KAR 5:066, Section 17. In addition, upon written request of any customer, the meter serving said customer shall be tested by the District. Such test shall be made without charge to the customer if the meter has not been tested within twelve months preceding the requested test; otherwise, a charge of \$2.00 plus actual cost of test will be made and then only if the test indicated meter accuracy within the limits of 7%.
