SUPPLEMENT TO CONTRACT FOR PURCHASE OF TREATED WATER

THIS SUPPLEMENT TO CONTRACT for purchase of treated water made and entered into this 13/4 day of October, 1976, by and between Elihu-Rush Branch Water Association, Inc., and hereinafter sometimes referred to as "Water Association" or "Association", a non-profit corporation duly organized and existing pursuant to the provisions of Chapter 273 of the Kentucky Revised Statutes, acting by and through its duly authorized corporate officers, and Kentucky Water Service Company, Inc., hereinafter referred to as 'Water Company', a Kentucky Corporation acting pursuant to authority and direction heretofore granted by its Board of Directors as its duly authorized and and an area of the control o empowered governing body;

WITNESETH: That whereas, the parties hereto on November 5, 1971, entered into a contract for the purchase of treated water which expires on November 5, 2011, and,

WHEREAS, the Water Association has made application for a loan and grant to extend its water system;

AND, WHEREAS, the period of the proposed loan would expire on or about November 30, 216, and it will be necessary that the Water Association have a contract for the purchase of water expiring on approximately the same date;

AND WHEREAS, the parties have agreed to extend the original contract dated November 5, 1971, to and including November 30, 2016;

NOW. THEREFORE, for and in consideration of the mutual promises, covenants, and agreements hereinafter contained, and the premises heretofore stated, it is now therefore further agreed as follows:
