## AMENDMENT NO. 3 TO THE CONTRACT FOR PURCHASE OF TREATED WATER BETWEEN CITY OF SOMERSET, KENTUCKY AND

## ELIHU-TATEVILLE WATER ASSOCIATION, INC.

IT IS HEREBY AGREED by and between the City of Somerset and the Elihu-Tateville Water Association, Inc., that the terms of the existing second supplement to Contract for purchase of treated water between both parties as executed on the 16th day of February, 1981, be amended as follows:

The City of Somerset is the successor in interest to 1. Kentucky Water Service Company, Inc. by way of the asset purchase of the Kentucky Water Service Company, Inc. by the City of Somerset in a contract dated the 23rd day of December, 1985.

2. Water Association has obtained a loan in the amount of \$305,000.00 from Farmers Home Administration, a facility of the U.S. Department of Agriculture, evidenced by Promissory Note, secured by Mortgage on plant facilities and pledge of certain revenues to the Farmers Home Administration payable over a period of forty (40) years from the date of said loan. Contract shall be in effect for forty (40) years from date of said Promissory Note.

3. The water will continue to be furnished at alor KENNUCE COMMISSION locations. All the suppliers users will proportionateler power e any incurred shortages.

The City of Somerset shall own and operate SFI 22 1994 4. facilities leading to and including the Master Meter, and the Elihu-Tateville Water Association, Inc., shall own SANT 10607 KAR5011, all facilities on the discharge side of the Master Meterion 9(1) BY:

The City of Somerset documents to ElihuFOTHEWille Water 5. Association, Inc., that it has an adequate supply and treatment facilities available to meet the needs of both Elihu-Tateville and Somerset's customers for the foreseeable future in Pulaski County.

This document does not in any way other than the terms set out herein, amend, repeal, or affect any of the terms, conditions and provisions of said Contract for purchase of treated water of the 16th day of February, 1981.
