

ORDINANCE NO. 9-90

AN ORDINANCE OF THE CITY OF CORBIN, KENTUCKY, REVISING RATES AND OTHER RELATED CHARGES FOR THE USE OF WATER AND SANITARY SEWER FACILITIES PROVIDED BY THE CITY UTILITIES COMMISSION OF THE CITY OF CORBIN, KENTUCKY, TO ITS USERS.

WHEREAS, the plant, equipment, and other related facilities supplying water and sanitary sewer services in the City of Corbin, Whitley, Knox and Laurel Counties, Kentucky, and the surrounding areas are owned by the City of Corbin, Kentucky, and operated by the City Utilities Commission of the City of Corbin, Kentucky; and

WHEREAS, the water and sanitary sewer operation and maintenance costs have increased considerably since the last general revision of rates and other related charges as outlined in Ordinance 11-81, of June 15, 1981; and

WHEREAS, the Board of Commissioners has considered the cost and value of existing, planned, and foreseeable needed utility facilities, the cost of operation and maintenance, repairs, replacements, extensions, and improvements, and the financial requirements for proper servicing of existing debt service; and

WHEREAS, it is necessary that the water and sanitary sewer rates and other related charges be adjusted to reflect these increases;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF CORBIN, WHITLEY AND KNOX COUNTIES, KENTUCKY, AS FOLLOWS:

Section 1: The Board of Commissioners of the City of Corbin, Kentucky, in conjunction with the City Utilities Commission of the City of Corbin, Kentucky, has determined that due to more stringent environmental regulations resulting in higher water and wastewater treatment costs and other substantial increases in operation and maintenance costs in the water and sanitary sewer systems that water and sanitary sewer rates must be increased to its customers.

Section 2: Beginning with bills dated June 1, 1990, the schedule of water and sanitary sewer rates and other related charges for services and facilities furnished by the combined and consolidated Utilities System of the City of Corbin, Kentucky, for all its users shall be revised as follows:






