WATER PURCHASE CONTRACT EXTENSION AND AMENDMENT  
AMENDMENT III

THIS CONTRACT to extend the Water Purchase Contract dated June 28, 1973, and attached hereto and marked as Exhibit A, and incorporated by reference as if fully set forth herein, is by and between the CITY OF HOPKINSVILLE, KENTUCKY, acting by and through its duly authorized agency, THE HOPKINSVILLE SEWERAGE AND WATER WORKS COMMISSION, hereinafter referred to as the "Seller", and CHRISTIAN COUNTY WATER DISTRICT, 1960 Dawson Springs Road, Hopkinsville, Kentucky 42240, hereinafter referred to as the "Purchaser".

WHEREAS, the Parties entered into a Water Purchase Contract dated June 28, 1973; and

WHEREAS, Purchaser previously requested time extensions for said contract which resulted in the Water Purchase Contract Extension of 1979 and the Water Purchase Contract Extension and Amendments dated August 18, 1982, and 1988, all of which are attached hereto as Exhibits B and C and D respectively, and incorporated by reference as if fully set out herein; and

WHEREAS, the Purchaser has received additional funding approval from the Farmers Home Administration for Phase III-A, B and C expansions and has requested an additional time extension which would in no way alter the rate formula or the previously established formula for rate increases as set forth in the original contract; and

WHEREAS, the Seller is willing to extend the term of the said contract once again; and

NOW, THEREFORE, the parties agree as follows:

1. In consideration of the foregoing and the mutual agreements set forth in the original Contract and to accommodate the Purchaser, it is hereby agreed by both parties that the orig-

inal Water Purchase Contract of June 28, 1973, three times previously extended, shall be extended so that if the Purchaser exercises its option to extend the Contract for an additional term of twenty years as set out on page 5, paragraph C(1) of Exhibit A, the original contract, then the second twenty-year term will be deemed to expire on December 31, 2030.

2. Except as set forth in paragraph 1 herein, the original Water Purchase Contract of June 28, 1973 and all amendments and additions thereto shall remain in full force.

3. This extension agreement was approved at a meeting of the Board of the Seller on the 15th day of August, 1990, and at a meeting of the Board of the Purchaser on the 2nd day of AUGUST, 1990.
