

AMENDMENT NO. 6

THIS AMENDMENT, entered into as of this 24th day of September, 1991, by and between **BIG RIVERS ELECTRIC CORPORATION**, having a postal address of P.O. Box 24, 201 Third Street, Henderson, Kentucky 42420 ("Big Rivers"), and **GREEN RIVER ELECTRIC CORPORATION**, having a postal address of P.O. Box 1389, Owensboro, Kentucky 42302-1389, ("Green River"), both parties being cooperative corporations organized and operating under KRS Chapter 279 and related chapters and sections of the Kentucky Revised Statutes.

WHEREAS, the parties hereto entered into an amended and restated agreement dated February 16, 1988, as amended on June 14, 1989, twice on December 8, 1989, on March 28, 1990, and on September 23, 1991, regarding the terms and conditions on which Big Rivers would sell Green River electricity for resale to certain large industrial customers of Green River, referred to in the present instrument as the "Agreement", and

WHEREAS, the parties now desire to amend the Agreement to reflect the effect on the Agreement of the September 24, 1991, Amendment No. 1 to the April 25, 1983, retail electric service agreement between Green River and Green River Coal Company,

NOW, THEREFORE, in consideration of the mutual covenants of the parties hereto, the parties agree as follows:

1. Exhibit 1 to the Agreement shall be amended to read as set out on the revised Exhibit 1 attached hereto and incorporated herein by reference.

2. Paragraph (3) of the Agreement is amended to add the following subparagraph (d):

(d) The other provisions of this Agreement notwithstanding, with respect to the retail electric service agreement between Green River and Green River Coal Company dated April 25, 1983, as amended by amendment dated September 24, 1991:

i. Green River shall have and retain the benefits of paragraphs 3.01(c) (additional payment of \$1,000.00 per month) and 3.03(b) (minimum demand) of that retail electric service agreement, as amended, and

ii. Big Rivers, in calculating Green River's monthly billing demand at the Green River Coal Company delivery point shall use the historical billing demand assumptions contained in paragraph 4 of Amendment No. 1 to that retail electric service agreement.

3. The effective date of this amendment shall be the date upon which the last of the following conditions precedent occur:

A. this amendment has been approved in writing by the Administrator of the Rural Electrification Administration of the United States, and

B. this amendment has been filed with the Public Service Commission of Kentucky and has been approved by such Commission by order or by action of law under the Kentucky statutes and the Public Service Commission's rules and regulations.
