AVAILABILITY

Available in communities indicated on Sheet No. 2 of this schedule, where secondary distribution lines are adjacent to the premises to be served.

APPLICABILITY

Applicable to electric service, other than three phase service, for all domestic purposes in private residences, and single-occupancy apartments. Residences where not more than two rooms are used for rental purposes will also be included. Where multi-occupancy buildings are served through one meter this Rate will be applied on a "per residence" or "per apartment" basis. 
