I. Rules and Regulations for the Government of gas utilities which may be adopted by the Public Service Commission of Kentucky, and all amendments thereto and modifications thereof which may be made by said Commission.

RATES

Applicable:

Entire territory served.

Availability of Services:

Available for domestic, house heating, commercial and industrial service to all users on existing mains of the gas distribution system of the Company.

Rates:

Domestic

First 1,000 cu. ft. used per month	\$ 1.30 (Net)
All over 1,000 cu. ft. used per month	.70 (Net)

House Heating:

First 1,000 cu. ft. used per month	\$ 1.30 (Net)
Next 10,000 cu. ft. used per month	.62 (Net)
All over 11,000 cu. ft. used per month	.55 (Net)

Commercial and Industrial

First 1,000 cu. ft. used per month	\$ 1.30 (Net)
Next 10,000 cu. ft. used per month	.62 (Net)
All over 11,000 cu. ft. used per month	.55 (Net)

Minimum Charge:

The minimum charge shall be \$1.30 for all classes of service.

Special Rules:

Bills will be computed at both net rate (above) and the gross rate. Gross rate is Net Rate plus \$.05 per thousand cubic feet of gas billed. The net bill is payable within ten (10) days of the bill. The bill is payable at the office of the company in London, Kentucky, and after ten (10) days from the date of the bill, the Gross Rate is payable.

RULES AND REGULATIONS

I. Rules and Regulations for the Government of gas utilities which may be adopted by the Public Service Commission of Kentucky, and all amendments thereto and modifications thereof which may be made by said Commission.

II.

RATES

Applicable:

Entire territory served.

Availability of Service:

Available for domestic, house heating, commercial and industrial service.

Rates:

Domestic

First 1,000 cu. ft.	\$1.50
All over 1,000 cu. ft.	.40 per Mcf

House Heating, Commercial and Industrial

First 1,000 cu. ft.	\$1.50
Next 10,000 cu. ft.	.60¢ per Mcf
All over 11,000 cu. ft.	.55¢ per Mcf

Minimum Charge:

The minimum monthly charge shall be \$1.50 for all classes of service.

Special Rules:

The above rates to be paid for monthly as bills are furnished, as hereinafter set forth, to the customer, and in case such bill is paid on or before the 10th of the month, succeeding the month in which the gas is consumed, the same shall be discounted at the rate of 5¢ per thousand cubic feet. Said bill shall be payable at the office of the grantee in London.

Sec. 14. No monthly statement shall be rendered for less than one thousand cubic feet of gas, which shall be a minimum monthly charge, and which will cover any amount of gas consumed less than one thousand cubic feet, service of meter reading, rendering of statements and any ready to service charge.
