

AGREEMENT

THIS SUPPLEMENTAL GAS SALES AGREEMENT, made and entered into between KENTUCKY WEST VIRGINIA GAS COMPANY, a West Virginia corporation, PARTY OF THE FIRST PART, hereinafter referred to as "SELLER", and M. D. BAILEY, of Paintsville, Johnson County, Kentucky, PARTY OF THE SECOND PART, hereinafter referred to as "BUYER".

WITNESSETH: That

WHEREAS, Seller and Buyer have heretofore on the 21st day of December, 1957, entered into a written contract for the sale of natural gas upon the conditions, terms, covenants and stipulations therein more particularly set out, which contract was amended by letter agreement dated September 21, 1959, and extended by agreement dated as of December 21, 1962, all of which are referred to for greater certainty, and

WHEREAS, the parties desire to extend such contract as amended for a period of five (5) years to December 21, 1972, upon the same conditions, terms, covenants and stipulations,


NOW, THEREFORE, in consideration of the premises, the Seller and Buyer do hereby extend such contract of December 21, 1957, as amended, upon the same conditions, terms, covenants and stipulations set forth therein, for a period of five (5) years from December 21, 1967, to December 21, 1972. The price to be paid by Party of the Second Part to Party of the First Part for all natural gas delivered under the terms of this contract shall be Thirty-five cents (\$.35) per one thousand (1,000) cubic feet. Provided, however, either party may reopen this contract as to rates at the end of any contract year by giving the other party written notice of its intention to do so at least thirty (30) days before the end of such year, and notice mailed by registered

or certified mail shall be sufficient and shall be deemed received when mailed. Upon reopening, the rates provided for herein or otherwise fixed may be altered by negotiations, or by any regulatory body having jurisdiction upon the application of either party.




