Regulations of the Public Service Commission shall apply even though not specifically set forth herein.

REVISIONS

These rules and regulations may be revised, amended, supplemented or otherwise changed from time to time subject to approval of the Public Service Commission and shall have the same force as the present rules and regulations.

SERVICE AREA

The utility furnishes sewage service to various family and multi-family residences located on Lawrenceburg Road, Evergreen Road and Lawrence Street in Frankfort, Franklin County, Kentucky.

NOTICE OF TROUBLE

Consumer shall give immediate notice to the Utility of any irregularities or unsatisfactory service or of any defects known to consumer.

MAINTENANCE

The Utility may at any time deemed necessary, suspend sewer service to any customer or consumers for the purpose of making repairs, changes or improvements upon any part of its system. The Utility shall give reasonable notice of such suspension of service to the consumer.

The Utility shall be responsible for the maintenance of that portion of the service line installed by the Utility and the consumer shall be responsible for the maintenance of that portion thereof installed by the consumer.

BILLING AND COLLECTION

For those customers billed directly by the Utility, bills for sewage service furnished by the sewer company are done through coupons that are provided to the consumer and will be due and payable by the 10th of the month. (T)

For those customers billed by Farmdale Water District, bills for sewage service furnished by the sewer company will show up on the monthly water bill from Farmdale Water District. Such bills will be due on the date specified in Farmdale Water District's tariff and are to be paid to Farmdale Water District. (N)
