BE ADVISED that, with this letter, Cinergy Communications Company (hereafter "Cinergy") hereby petitions the Kentucky Public Service Commission for approval to change its name to Norlight, Inc. (hereafter "Norlight"). We have already changed the name with the Secretary of State's office. Also please note that we have obtained authorization from the Secretary of State's Office to use the assumed name of Cinergy Communications. It is our intent, upon Commission approval, to use the Norlight name to market our enterprise products and to use the name Cinergy Communications to market our residential products.


I have attached the following exhibits for your review:







3) Q-Link DSL/150 – This package includes Q-Link business lines at \$25.95 per line per month, with DSL on at least one line for an additional \$49.95 per month. Customers will also receive 150 minutes of direct dial domestic long distance voice service per line per month when they subscribe to this package. In order to be eligible for this package, customers must subscribe to a minimum of 2 Q-Link business lines and they must sign a 36-month contract for all lines. This package is available for all business customers who subscribe to no more than 20 Q-Link lines and have an NPA-NXX that is listed in Attachment A.

In addition to the requirements listed above, customers who subscribe to the Q-Link Unlimited and Q-Link DSL/Unlimited packages must comply with the following terms and conditions.

- 1) Q-Link Unlimited and Q-Link DSL/Unlimited promotional packages cannot be used for placing interLATA or intraLATA long distance calls to on-line services, Internet access services, or broadcast facsimile services;
- 2) Q-Link Unlimited and Q-Link DSL/Unlimited promotional packages usage does not include multi-party conference calls (except those placed by using the Three-Way Calling features are included), calls to 900, 976, 700 numbers or other calls to access information services, directory assistance, calling card, operator services or international calling services and toll free calling services;
