Again – my apologies for all of the confusion.

Contract was ended because they are no longer providing telecommunication services. See attached FCC status which we submitted.

It states –

**No Longer Active as of Jul 31 2018.**

**This company still exists, however it is no longer providing telecommunications services.**

As I work remote I did not ask the right questions.

You asked if the letter I submitted over the weekend should state 2018 or 2019 – it really is 2018 as you can see from the attached.



You emailed Mark that you were missing the Annual Report which I was not aware of until this morning because I did not file those reports. It would make sense that it was "missing" if you still showed them active.

They are no longer a client because they are not providing telecommunication services. We were asked to cancel their registrations.

So – in summary – they are not providing services in KY and no longer need to be registered as a VoIP provider.
