DISCONTINUANCE OF SERVICE CONTINUED:

If discontinuance for nonpayment of bills, the customer shall be given at least five (5) days written notice, separate from the original bill, and cut-off shall be effected not less than sixty (60) days after the mailing date of the original bill unless, prior to discontinuance, a residential customer presents to the Utility a written certificate, signed by a physician, registered nurse, or public health officer, that such discontinuance will aggravate an existing illness or infirmity on the affected premises, in which case discontinuance may not be effected until the affected resident can make other living arrangements or until not less than thirty (30) days elapse from the date of the Utility's notification. When a dangerous condition is found to exist on the customer's or applicant's premises, the service shall be cut off without notice or refund. Additionally, when payments are delinquent, the Utility may file a Complaint in court. The Utility may obtain a judgment, including all costs incurred, and collect through all regular civil means.

RECONNECTION OF SERVICE

Any customer who has been forcibly or voluntarily disconnected may be reconnected upon payment of the outstanding charge, the normal deposit, plus a \$31.50 reconnection fee as listed in Attachment A "Special Charge Schedule".

BILLING PROCEDURE

NOTICE OF PAYMENT TO UTILITY

Notice of any problems, or remittance of payment, shall be effective or credited only when sent or remitted to the address by Utility to the consumer. Initially remittances and notices may be given to George Lucas at 8 Westwood Drive, Scottsburg, IN 47170. Upon twenty (20) days notice from the Utility, notices or remittances may be required to be forwarded to other individuals and failure to follow said notice or remittance instructions shall result in lack of notice or receipt by Utility.


