- 2. Any resident or business of Bandana Water District is eligible for water service from the District, providing a water main is within 100 feet of his property line.
- Water service will be terminated within 24 hours after receiving a written request from the customer requesting discontinuance.
- 4. All applications for service to rental property shall be accompanied by a \$10 deposit to assure payment of bill, except applications for service to trailers, which shall be \$15.
- 5. All applications for service shall be accompanied by a tap-on fee in the following amounts:
