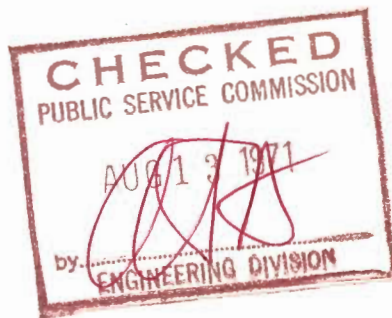

RULES AND REGULATIONS

The following rules and regulations are subject to change by the Water District Commissioners at any time.

1. Meters are read monthly between the 15th and 20th of each month.
2. Bills will be dated and mailed on the first of each month. Said bills will state that they are to be paid withing 17 days.
3. Complaints may be made to the operator of the system and may be appealed to the District Commission.
4. Water bills may be paid at Alice Lloyd College or mailed directly to the Caney Creek Water District, Pippa Passes Kentucky.
5. A penalty of 10% is added to all unpaid bills after the 17th day of the following month.
