**SECTION 4: SPECIAL NON RECURRING CHARGES continued**

**Service Related Charges:**

1. Service Call / Investigation Charge: \$ 35.00

Will be assessed when a customer requests the onsite presence of utility personnel to investigate a service problem and the problem is a result of the customer's own plumbing facilities, beyond the utility's delivery point, or not caused by failure of utility facilities. Any maintenance and repair of facilities beyond the utility's delivery point is the responsibility of the customer.

2. Service Disconnection Charge: \$ 35.00

Will be assessed to disconnect service that has been terminated for non-payment of service or for violation of utility or PSC rules and regulations.

3. Service Reconnection Charge: \$ 35.00

Will be assessed to disconnect service that has been terminated for non-payment of service or for violation of utility or PSC rules and regulations.

4. After Hours Service Reconnection Charge: \$ 45.00

Will be assessed to reconnect service that has been terminated for non-payment of service or for violation of utility or PSC rules and regulations.

5. Meter Read Charge. \$ 5.00

Will be assessed when a customer fails to read their own meter two (2) consecutive months and the Association has to send an employee out to read it for the customer.

**Billing Related Charges:**

1. Returned Check Charge: \$ 30.00

2. Late Payment Penalty: 10%

Will be assessed if a customer fails to pay a bill for services by the due date shown on the customer's bill. The penalty may be assessed only once on any bill for rendered services. Any payment received shall first be applied to the bill for service rendered. Additional penalty charges shall not be assessed on unpaid penalty charges.

**SECTION 10: BILLING; COLLECTIONS; PENALTIES.**

1. The rates or charges aforesaid shall be billed monthly on or about the last day of each month.
2. Bills for such service shall be due on or before the fifteenth (15th) day of the month and payable by mail or in person.
3. Payments must be received, not postmarked, before the close of business on the 15<sup>th</sup> day of the month. Eastern Rockcastle Water Association is not responsible for the United States Postal Service.
4. If a bill is not paid as aforesaid within such 15 day period, such bill shall be deemed delinquent, and there shall be imposed a penalty in an amount equal to ten percent (10%) of the charges (other than sales tax) shown on the face amount of said bill not so paid. The penalty may be assessed only on any bill for rendered service. If a bill is not paid within the first five (5) business days after becoming delinquent (20 days after rendition), service will be subject to disconnection.
