All Rules and Regulations are to be in effect so long as they are not in conflict with Public Service Commission Rules and Regulations. The Utility is further subject to all Public Service Commission Rules and Regulations even though not contained herein.

Revisions

These Rules and Regulations may be revised, amended, supplemented, or otherwise changed from time to time subject to approval of the Public Service Commission.

Service Area

The Utility furnishes water service to Lockwood Estate located in Boyd County, Kentucky.

Availability

Water service is available to any domestic, commercial, or industrial consumer within the Utility's service area.

Water Failure

The Utility is responsible for water failure only when in control of the Utility's employees. No consumer is paid damages for equipment unless such damages are specifically found to be caused by an act of negligence on the part of the Utility or its employees.

Protection by Consumer

Consumer shall protect the equipment of the Utility on his/her premises and shall not interfere with Utility property or permit interference except by duly authorized representatives of the Utility.

- A 10% late payment fee will be charged after the due date.


